Dear Mr. Mican,

On Tuesday, April 19, 2022, I was notified by the customer at 20920 N Myrtle, that you had relocated her mailbox without permission from her or the Colbert Post Office. Upon a visit to the site, I did find that the box has been moved. This appears to be a case of you, or someone on your behalf, tampering with the mailbox.

In my previous conversations with you, I had informed you of the fact that the mailbox was not to be moved from the current location. As it is not a "safety" violation for current delivery, I can't demand your neighbor move their box. I also informed you that if you chose to still want to move the box, legal action on your part would be required and that it was not an issue for the Post Office.

Please contact me immediately regarding returning the mailbox to its original location or to the agreed upon location that I have discussed with your neighbor. Should you choose to not abide with this, I will have no option but to report this to the postal inspectors.

Again, please contact me as soon as possible at (509) 238-5134 to resolve this issue.

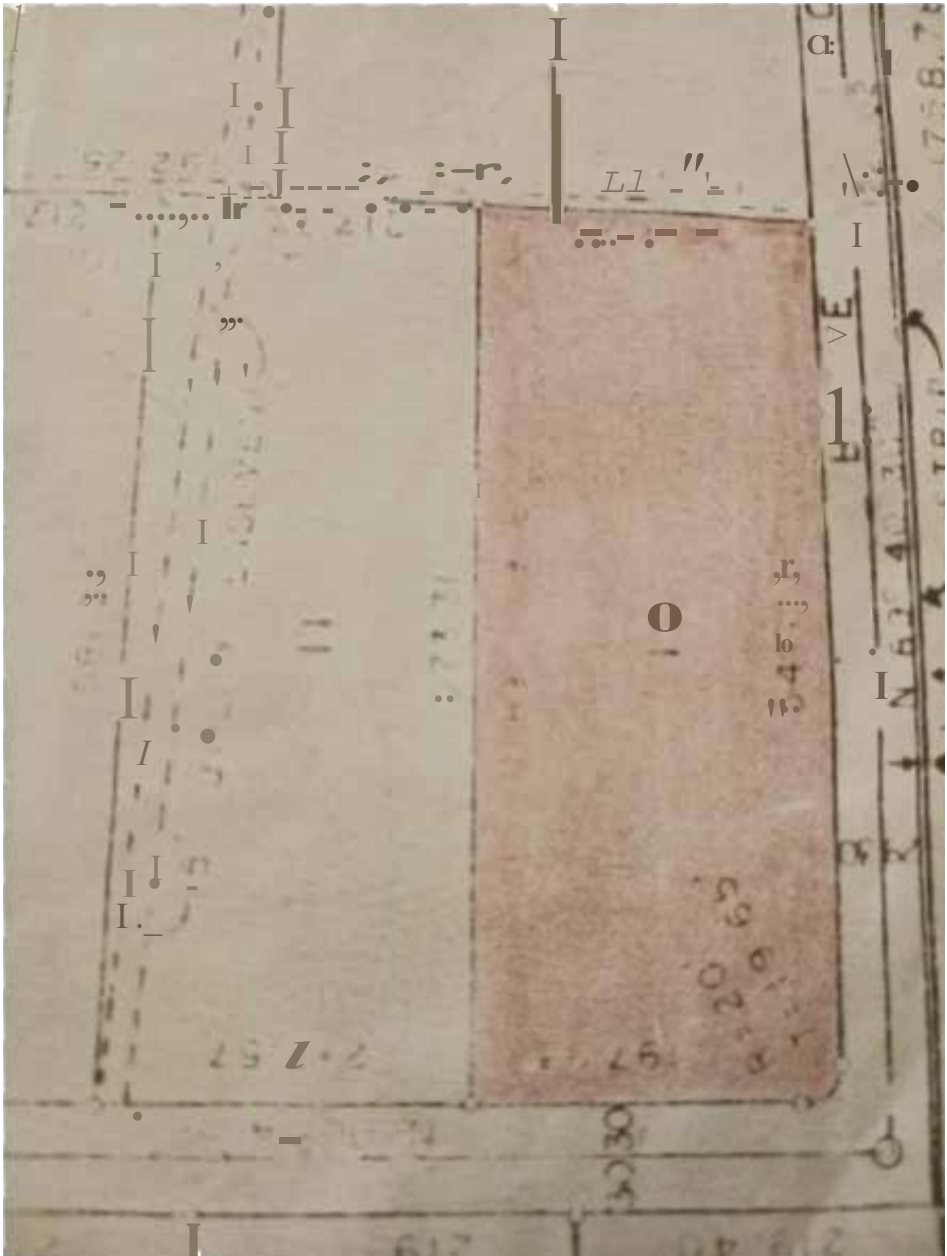

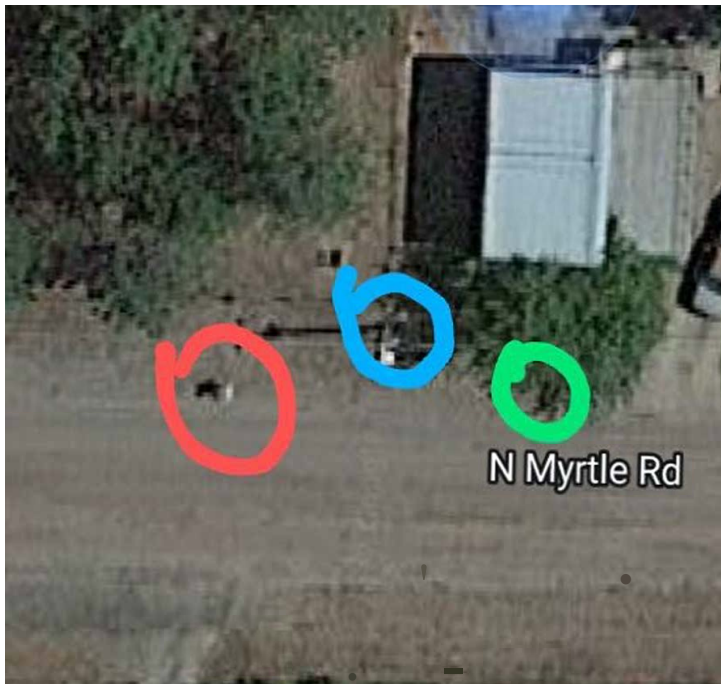

Google map old mailbox location-red , new mailbox location (green) and power pole/communications box (blue)

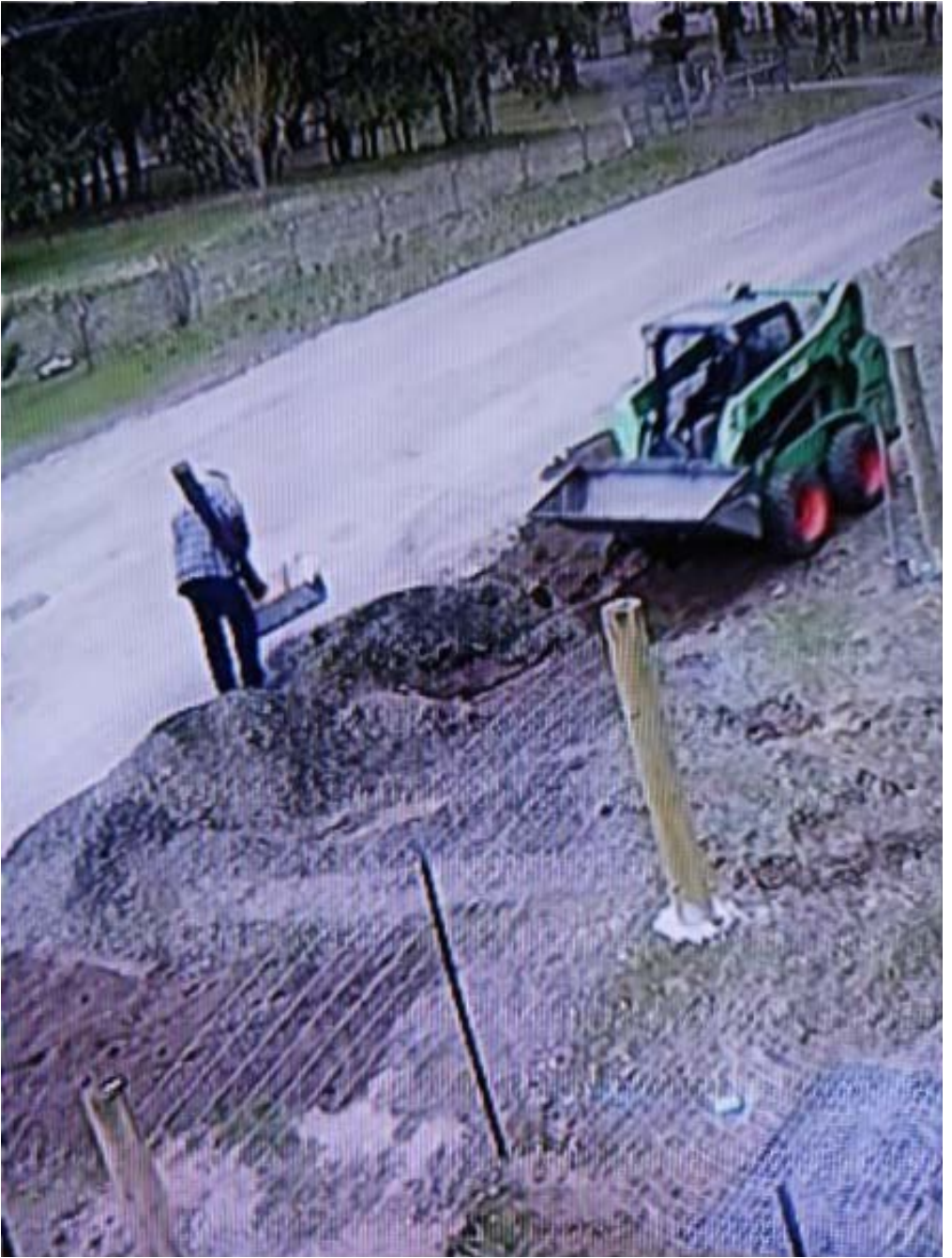
