**SPECIAL FUEL SURCHARGE SUPPLEMENT NO. 3**

The Commission approves a temporary 0.24% fuel surcharge in all rates and charges as a result of increased fuel costs incurred by the company during the months of August 2022, September 2022 and October 2022, to be collected from customers as a separate line item on the billing, as follows:
