SPECIAL FUEL SURCHARGE SUPPLEMENT NO. 3

Applies on Carrier's Tariff No. 17

The Commission approves a temporary 2.73% fuel surcharge in all rates and charges as a result of increased fuel costs incurred by the company during the months of October 2022 and November 2022, to be collected from customers as a separate line item on the billing, as follows:
