**SPECIAL FUEL SURCHARGE SUPPLEMENT NO. 5**

The Commission approves a temporary 1.54% fuel surcharge in all rates and charges as a result of increased fuel costs incurred by the company during the months of February 2023 and March 2023, to be collected from customers as a separate line item on the billing, as follows:
