The company requests Commission approval to amend its filed Tariff Number 17 on Less Than Statutory Notice to increase its Special Fuel Surcharge Tariff Supplement to recover the rising cost of fuel. Fuel index prices have increased from \$2.7762 per gallon for the base period to \$4.3820 per gallon current price. The proposed change is to implement a 1.20% surcharge in Supplement 6. Supplement 5 will expire on June 30, 2023.
