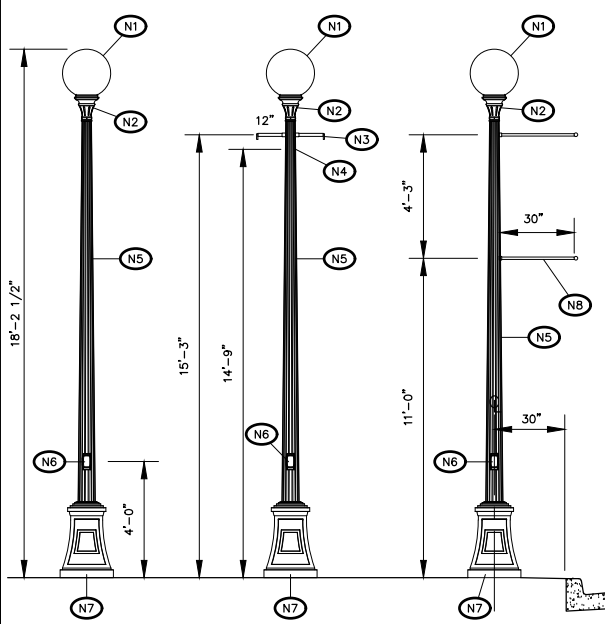

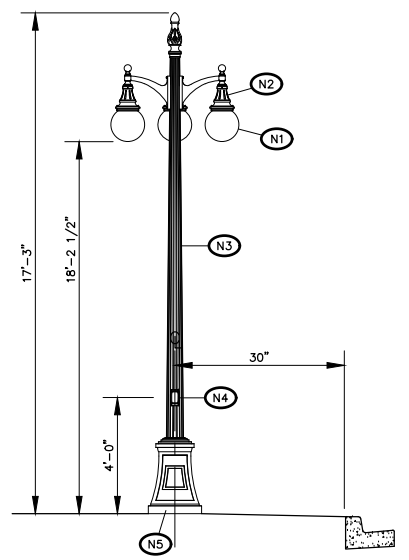


2.3 PEDESTRIAN LIGHT

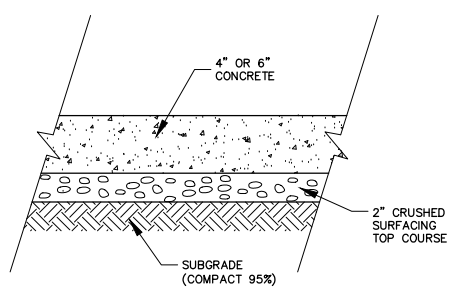

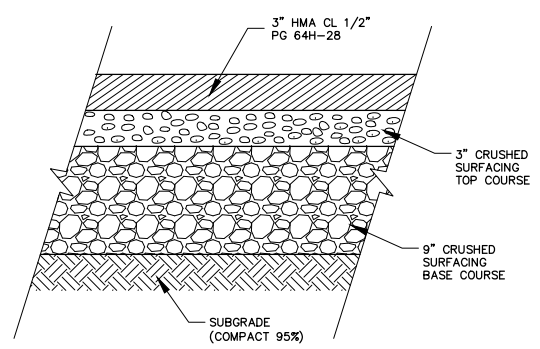
2.1 EXPANSION JOINT DETAIL

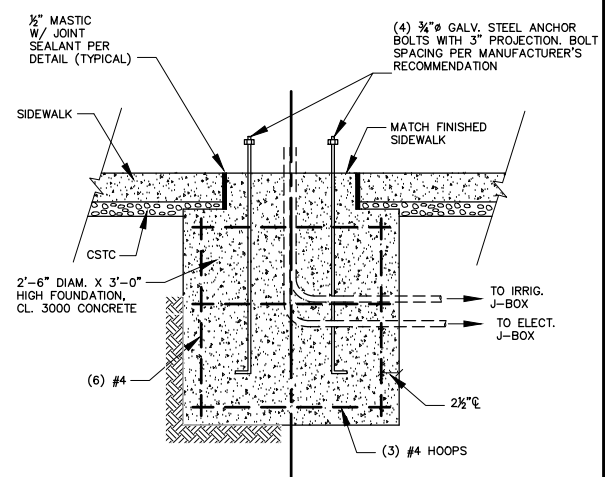

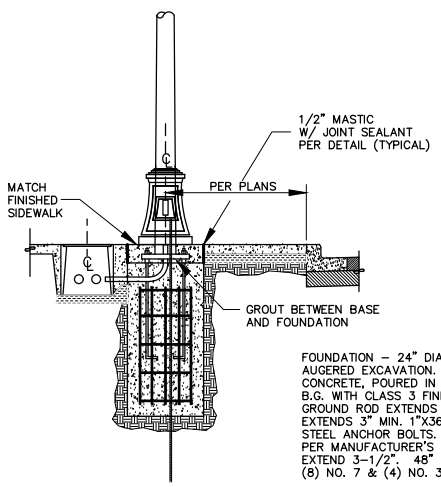

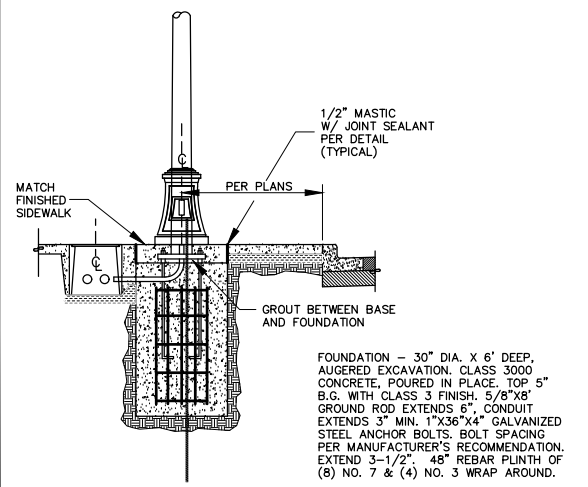
3.2 TYPICAL ROADWAY SECTION
