Under RCW 81.28.050, 45 days are required for customer notice of any tariff changes.

We are requesting to follow WAC 480-70-271 (2)(a) which would allow for notification on the customer's first invoice after approval.

**\* Explain why the company is proposing this tariff revision:**  
We are requesting this change as it lowers cost to the rate payer by notifying them along with their invoice.

**\* Explain why the Commission should allow this tariff revision to take effect with less than 30 days' notice (45 days' notice for solid waste):**  
This has been historical procedure and the direction we received is that for disposal and commodity rebate filings, notification on their first invoice after approval is sufficient.
