The Department of Ecology (Ecology) received Clark County's Preliminary Draft Comprehensive Solid Waste Management Plan (Plan) and a formal request for review of the Plan on June 28, 2024. The UTC shall then review the Plan's assessment of solid waste collection cost impacts on rates charged by solid waste collection companies regulated under chapter 81.77 RCW and advise the submitting entity and Ecology of the probable effect of the plan's recommendations on those rates.
