IMPORTANT NOTICE

January 30, 2025

Wildwood Water Company, LLC has asked the Washington Utilities and Transportation Commission to approve an application to increase rates. If approved, the new rates will become effective March 1, 2025. If approved, this increase will generate an additional \$38,399 annual revenue.

The increase is to cover the increased costs for management services and other associated costs of servicing the water system. These increased costs are primarily from the new rates set by King Water Services (who services the water system), as well as for higher rates from other companies that perform services for the system (like pest control), and for Cost of Living Adjustments (COLA).

0-500 (cu. ft.)	\$1.85	\$3.00
501-1,000 (cu. ft.)	\$2.75	\$3.75
Over 1,000 (cu. ft.)	\$3.25	\$4.75

Usage rates are per 100 cubic feet. One cubic foot = approx. 7.48 gallons.
