On April 28, 1994, Point Fosdick Water Company, Inc., (Point Fosdick) filed with the Commission, revisions to its currently effective tariff WN U-1 in Docket UW-9405-62. The current effective date is June 1, 1994. Point Fosdick currently serves approximately 254 water customers in the Gig Harbor area.

The revisions are designated as:

- Third revision of Sheet 21, Schedule 1, Flat Rate
- Second revision of Sheet 22, Schedule 2, Metered Rate

The Commission, on May 25, 1994, entered a Complaint and Order Suspending Tariff Revisions pending an investigation concerning the charges and reasonableness and justness thereof.

Point Fosdick has proposed new rates due to an increase in water testing, and daily operating expenses.

Point Fosdick Water Co., Inc., serves 116 flat rated customers and 138 metered customers living in the Gig Harbor area of Pierce County. The company plans to meter all customers over the next four years.

FINDINGS


1. Point Fosdick is a water utility company and as such is a public service company subject to the jurisdiction of the Commission.
2. The revisions presently under suspension herein are not considered to be unreasonable.
3. It is not contrary to public interest that the Compliant and Order Suspending Tariff Revisions in this docket be dismissed and that the revisions to the respondent's filed Tariff WN U-1 become effective June 9, 1994.

ORDER


