The FCC issued their order in October 2020 but did not provide the method that was to be used in calculating the commensurate intrastate rates until mid-May 2021. It took several weeks to develop the demand data necessary to calculate the intrastate rate revisions, a process which was not complete until last week. Fortunately, the intrastate access tariff largely adopts the rates in the underlying FCC tariff by reference which results in minor text changes to the tariff language.
