## NOTICE OF PROPOSED RATE CHANGES FOR 2" METERED CUSTOMERS

Great Basin Water Co Burbank LLC has asked the Washington Utilities and Transportation Commission for permission to increase the water rates we charge all our customers. The proposed rates will increase annual revenues to the company by approximately \$169,137 (55%) per year to cover increased operating expenses of labor, insurance, fuel, electricity, etc. If approved, the new rates will be effective on November 1, 2021. The rate increase will be based on water used after November 1, and reflected on your November 30, 2021 billing.

Below is a table showing the current and proposed water rates for 2" meters (cu ft = cubic feet):
