I PRELIMINARY STATEMENT

Basin Disposal, Inc., 2021 N. Commercial Ave., Pasco, WA, (hereinafter "Basin" or "Complainant"), a Washington corporation, and holder of Certificate of Public Convenience and Necessity ("Certificate") No. G-118, pursuant to RCW 81.04.110 and 81.77.030, brings this Complaint against Jammie's Environmental, Inc., ("Jammie's" or "Respondent"). Complaint asks the Washington Utilities and Transportation Commission ("Commission" or "WUTC"), to find the Respondent in violation of RCW 81.77.040 issue an order directing Respondent to cease and desist from engaging in the collection and transportation of solid waste in Walla Walla County for disposal without certificated authority.

II JURISDICTION / STATUTE AND RULES AT ISSUE

2 The Commission has jurisdiction over this Complaint and the Respondent's activities described herein under RCW 81.04.110, 81.77.040, RCW 34.05.413, WAC 480-70-006, 041 and various other laws and rules cited herein.

III STATEMENT OF FACTS

- 3 Complainant is the holder of WUTC Certificate G-118, attached hereto as Exhibit A, which authorizes Complainant to collect solid waste in, among other places, Walla Walla County.
- 4 Respondent is a public service company subject to the Commission's jurisdiction with an address of 128 Industrial Way, Longview, WA 98632. Jammie's is authorized by the Commission to serve as a common carrier under common carrier permit CC-70115, as well as an authorized motor carrier with authority issued by the United States Department of Transportation under MC-390939 and USDOT Number 892456. Respondent has not been authorized by the Commission to provide solid waste collection service in any portion of Walla Walla County, Washington.
- 5 Respondent has repeatedly engaged in the collection and transportation of solid waste over the public highways of the state by motor vehicle, as defined by WAC 480-70-041, from a paper mill operated by Packaging Corporation of America ("PCA") in an unincorporated area of Walla Walla County, Washington near Wallula, Washington.
- 6 Respondent collects and transports solid waste in the form of old corrugated cardboard rejects ("OCC Rejects") from PCA solely for disposal. On information and belief, Respondent collects and transports multiple loads of solid waste from PCA each weekday for disposal.

IV BASIS FOR COMPLAINT

- 7 RCW 81.77.040 requires a solid waste collection company to obtain a certificate of public convenience and necessity from the Commission to operate for the collection and hauling of solid waste for compensation authorizing service in a particular area. By statute, operating for the collection and transportation of solid waste for compensation includes advertising, soliciting, offering, or entering into an agreement to provide that service.
- 8 Under RCW 81.77.090, every person who violates or fails to comply with, or who procures, aids, or abets in the violation of any provisions of RCW 81.77, *et seq.*, or who fails to obey, or

comply with any rule, regulation, or requirement of the commission, or any part or provision

thereof, is guilty of a gross misdemeanor.

9 On information and belief, Jammie's held itself out as a solid waste collection company and/or

contracted with PCA to provide solid waste collection service in Walla Walla County,

Washington in violation of RCW 81.77.040.

10 By collecting and transporting solid waste from PCA, Respondent unlawfully provides solid

waste collection service in violation of RCW 81.77 et seq.

V REQUEST FOR RELIEF

11 WHEREFORE, Complainant requests the Commission permit the full range of discovery as

authorized by WAC 480-07-400(2) and for an order finding, on the facts to be adduced on this

record, that the collection and transportation of solid waste for disposal from PCA industrial

paper mill in unincorporated Walla Walla County is subject to the provisions of

RCW 81.77.040, and directing Respondent to cease and desist from engaging in the collection

and transportation of solid waste from the PCA industrial paper mill located in Walla Walla

County.
