Dear Residential Customer,

This is to notify you of a proposed rate adjustment for residential services in the City of Edmonds, WA, where Sound Disposal, Inc. operates. It has been thirteen (13) years since our last general rate increase. This notice informs you of a proposed change in the garbage collection portion of your invoice. Sound Disposal, inc. has filed a request to adjust the residential garbage collection rates with the Washington Utilities and Transportation Commission (UTC). If the UTC approves this request, the new rates (shown below) will become effective July 1, 2022,

Our goal is to provide you with high-quality collection services at the lowest possible costs. We work hard to keep rates low, but significant increases in labor, insurance, **fuel**, and maintenance costs have made it necessary to request a rate adjustment.

The proposed rate adjustment for our residential service is approximately 29%, as shown above (note: this list above does not include all services we offer. If you have questions about this proposed rate adjustment, you may call the company at (425) 778-2404.

The Commission has the authority to set final rates that may be either lower or higher than the company's requested adjustment, depending on the results of its investigation.
