Mr. Gomez:

This is to notify you that beginning June 1, 2022, disposal rates will increase at the Olympic View Transfer Station (OVTS). This rate adjustment was based on the findings of a recently-completed cost of service/rate study. The Kitsap County Board of Commissioners adopted these new rates by resolution (Resolution No. 026-2022, "A Resolution Establishing the Fees charged at the Olympic View Transfer Station") on February 28, 2022. Please note that this resolution also includes rate increases to be effective January 1, 2023, January 1, 2024, January 1, 2025 and January 1, 2026. The new rates are shown in the table on the reverse side of this letter. Resolution No. 026-2022 is also attached.

Kitsap County Public Works Solid Waste Division, as owner of OVTS, is providing the required minimum seventy-five days' notice of the changes in tipping fees and disposal rate schedules, in accordance with RCW 70A.205.160. This notification is to provide solid waste collection companies sufficient time to prepare budgets and/or submit tariffs and rate filings for public comment and UTC approval.

Should any mid-stream adjustments need to be made to the rates in the attached resolution, the Solid Waste Division will issue timely notifications.
