You may not take the pet out, or touch them, along the route, as we are sensitive to people with allergies. Pets are \$20 each way. Schedule Maintenance: Carrier will not be liable for delays caused by accidents, breakdowns, bad road conditions, snowstorms, or other conditions beyond the control of the carrier and does not guarantee arrival at, or departure from, any point at any specific time.
