Dear Ms. Washburn:

Please find attached several copies of items indicating our attempts at delivering Ms. Gertraude Taut a final billing. This correspondence does not dispute the final order by the Commission.

As of today we have not received payment per the final order given by the Commission. The purpose of this letter is to document the attempts we have made in delivering this to Ms. Taut and receive release in order to conclude this matter.

On January 16, 2003, All My Sons Moving & Storage received the Final Order from the Commission regarding the above referenced docket. All My Sons prepared a final billing for Ms. Taut (attached).

On January 17, 2003, All My Sons Moving & Storage contacted Ms. Tani Thurston with the Commission in order to affirm that the final billing was correct and within the guidelines set forth by the Commissions order.

Additionally, during the conversation with Ms. Thurston, All My Sons Moving & Storage indicated that the only address that we had been given for Ms. Taut was the P.O. Box listed in her complaint. Ms. Thurston indicated that she had a physical address in Milton that she was instructed to use to deliver the commissions paperwork. She also indicated that there were instructions to deliver items to the back of the residence.

As the commission order required a billing within 3 days of the final notice date, All My Sons Moving & Storage was required to overnight Saturday delivery via airborne express the billing to Ms. Taut. Airborne Express does not overnight to P.O. Boxes, so we indicated to Ms. Thurston that we would forward via regular mail an additional copy of the billing to Ms. Taut's P.O. Box.

On January 18, 2003, Airborne Express contacted our office and indicated that Ms. Taut did not reside at that location and the residents were unaware of who she was. We

indicated to Airborne Express to return the letter to our office. Please see that attached tracking information affirming that an attempt was made on 1/18/03 to deliver the final billing.


On January 22, 2003, All My Sons Moving & Storage spoke with Ms. Thurston from commission and indicated that our attempts at certifying a delivery to Ms. Taut had failed and Ms. Thurston indicated that it would be in our interest to mail another copy of the final billing to the P.O. Box via certified U.S. Mail. This was subsequently done on the same day per the attached receipt.

As you can see, All My Sons has attempted within all reasonable ways to deliver this billing to Ms. Taut and we believe we have fully complied with the Commissions order.

At this point, in order to prevent further delays or "stonewalling" tactics by Ms. Taut we would like to be informed that we may proceed to collect the debt Ms. Taut has incurred.



In response to the final order on the adjudicative proceeding, we are providing you with a billing in compliance with the commission's order.
