Description of amendment: eliminates UNE-P and implements batch hot cut process and discounts.

The amendment amends the interconnection agreement first approved by the Commission on February 6, 2004 in WUTC Docket No. UT-033035 (original docket number), and any amendments approved to date in WUTC Docket No. UT-043126.
