The only regret I had was that, I didn't listen to my guts on bringing a written explanation or notes that could of a help with the case. I had a draft but wasn't able to print a copy as I wasn't able to finish it in time. I am not blaming my baby for that but I do devote time for my baby.

I wish I knew well as to how to construct sentences, just like a native English speaker. I know I can speak and understand English but I am aware too that my capability has limits like I keep mistakenly say words rumbling from I and We, He or She that creates confusion. Those are little words but a powerful one.

I cannot literally sleep tonight thinking I have wasted my chance on asking the right question or explaining on the matters. I wish I could of asked Mr. Tinnerstet the question that as to why they strongly believed my husband will be or will take part of the ownership of the propose business I am opening. I am not sure if there is a law prohibiting couple or two individuals to have different businesses on the same location/address.

I wish I could of asked him too if he did know the circumstances of the conviction of my husband last 2010 dv. I am not in the position to discuss further with regards to his conviction but I want to make myself feel better by at least letting you know that my husband is not a person who he is base on his past records.

I am not saying this not because he is my husband but because I know him as a person. He never is a threat to me. I know domestic violence is very serious and I am glad there is a law here that takes it seriously. But if only the investigator dug deeper as to whether the conviction was really defining my husbands personality. I can vouch that he is not that type of person. He is a good person, father to our son and husband to me.

If you remember at the hearing your honor, I was referring to a print out that I was not able to present at the end of the day. That was a printout of the lady who put him in prison for dv. I believed my husbands story based on how the lady trying to reach him as soon as he was out of jail, I even heard the voicemails but dont have a copy. I myself was being contacted by the same lady thru myspace account telling me "to take care of him as he is a good person and he deserves to be happy", that was back in 2013 after we got married, I just happen to have deleted her message to show respect to my husband as he was hurting. He was hurt by the fact he has to spend months in jail for not doing the crime. I believed in him because IF he really did that allegedly dv, then why the lady is still trying to reach him by all means, if he is really a threat to her, then she shouldn't/wouldn't try messaging and reaching out to him. If it was me, I will not try to contact or reach a person who shows threat to me, that is just my opinion.

I am attaching of the photo of the message she sent to my husbands facebook account dated May 20, 2014. I know this is not totally relevant with the case but no matter what explanation I am going to give, it goes back to my husbands background, I wanted to correct that perception, assumption because I do believe not all people who spent time in jail is really guilty of the accusations they were accused of. I am proud to say ,my husband is not a bad person and I know If I am given the chance, my husband will never be an interfere to my operations. I want to establish myself. I want something that I can be proud of, that I am able to make a difference. Something that my son will be proud of in the future. Life is not a guarantee so I want to make the most of it while I can.
