**NOTICE OF HEARING ON RENEWED MOTION FOR CANCELLATION OF  
HOUSEHOLD GOODS CARRIER PERMIT  
(Set for Thursday, May 16, 2019, at 10 a.m.)**

RE: *In the Matter of the Investigation of MVP Moving and Storage, LLC For Compliance with WAC 480-15-560 and WAC 480-15-570, Docket TV-170039  
In the Matter of the Penalty Assessment Against MVP Moving and Storage, LLC In the amount of \$6,100, Docket TV-170038*

TO ALL PARTIES:

On April 6, 2017, the Washington Utilities and Transportation Commission (Commission) entered Order 01 in the above-referenced consolidated dockets. Order 01, among other things, required MVP Moving and Storage, LLC (MVP or Company) to pay a \$6,100 penalty, a \$3,100 portion of which was suspended for two years subject to several conditions, including the requirement that the Company pay the remaining \$3,000 penalty or file jointly with Commission staff (Staff) a proposed payment arrangement. On July 12, 2017, the Commission entered Order 03, which granted the parties' jointly proposed payment arrangement.

On May 9, 2018, Staff filed a Motion for Cancellation of MVP Moving and Storage, LLC's Household Goods Carrier Permit (Staff's Motion) based on the Company's failure to comply with the payment schedule approved by the Commission in Order 03.

On June 5, 2018, the Commission conducted a hearing on Staff's Motion. On June 7, 2018, the Commission entered Order 04, which denied Staff's Motion subject to numerous conditions, including the requirement that MVP develop an acceptable safety management plan approved by Staff. Order 04 expressly provided that Staff may file a new motion requesting the Commission cancel the Company's household goods carrier permit in the event MVP failed to satisfy any of the conditions.

On April 24, 2019, Staff filed a Renewed Motion to Cancel MVP's Household Goods Carrier Permit (Renewed Motion). In its Renewed Motion, Staff alleges that MVP has not complied with the conditions set out in Order 04, including, among other things, that the Company

submit an acceptable safety management plan. Accordingly, Staff requests the Commission cancel MVP's household goods carrier permit.

Pursuant to WAC 480-15-450(2), the Commission will hold a hearing prior to canceling a household goods carrier permit. Accordingly, the Commission will convene a hearing on Staff's Motion on **Thursday, May 16, 2019, at 10 a.m.**

Parties wishing to submit any documents for consideration at the hearing on Staff's Motion must file with the Commission a list enumerating and describing any such documents no later than 5 p.m. on **Thursday, May 9, 2019**, and bring an original and three (3) copies to the hearing. Filing shall be in accordance with WAC 480-07-140 and WAC 480-07-145.

**THE COMMISSION GIVES NOTICE That a hearing on Staff's Renewed Motion for Cancellation of MVP Moving and Storage, LLC's Household Goods Carrier Permit in Consolidated Dockets TV-170039 and TV-170038 is set for Thursday, May 16, 2019, beginning at 10 a.m., in Room 206, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.**
