DECLARATION OF  
JASON HOXIT

Jason Hoxit, under penalty of perjury under the laws of the State of Washington, declares as follows:

1. I am employed by the Washington Utilities and Transportation Commission (Commission) as a Compliance Investigator in the Safety and Consumer Protection Division. As a Compliance Investigator, my responsibilities include conducting investigations regarding the business practices of regulated utility and transportation companies. As part of those duties, I investigate charter party and excursion carriers that may be operating without the required Commission-issued certificate.
2. On April 30, 2018, I located a website for Seattle 7 Days Limo, a possibly non-certificated charter party and excursion carrier.<sup>1</sup> On Seattle 7 Days Limo's website it advertises a Hummer H2 Limo that seats 16 to 22 passengers, a stretched Hummer H2 Limo that seats 25 to 30 passengers, and a party bus that seats 14 to 22 passengers.<sup>2</sup> The website also advertises various hourly rates for a Hummer H2 Limo that seats 16 passengers, a stretch Hummer H2 that seats 22 passengers, an extra stretch Hummer H2 that seats 25 passengers, a super stretch Hummer H2 that seats 30 passengers, and a party bus that seats 22 passengers.<sup>3</sup>
3. I reviewed Commission records on April 30, 2018, to determine if Seattle 7 Days Limo's has an active charter party and excursion certificate. Commission records show that Seattle 7 Days Limo is not a certificated charter party and excursion carrier in the state of Washington.<sup>4</sup> Seattle 7 Day Limo's address on file at the

Commission is recorded as 22826 80th Ave. W., Edmonds, WA 98026, with an email address of support@seattle7dayslimo.com. According to records, the Commission notified Seattle 7 Days Limo that it was cancelling its certificate (CH-066145) on Dec. 23, 2016, due to insufficient proof of insurance, and directed the company to “immediately CEASE all operations associated with this certificate.”<sup>5</sup>

4. On April 30, 2018, I searched the Business Licensing Service through the Washington State Department of Revenue’s website for Seattle 7 Days Limo. I found the governing persons of Gurdip Singh and Jagdip Singh, and a mailing address of 22826 80th Ave. W., Edmonds, WA 98026.<sup>6</sup> I also found that Seattle 7 Days Limo has an active limousine endorsement through the Washington State Department of Licensing, which allows a carrier to operate an automobile with a seating capacity behind the driver of no more than 14 passengers.<sup>7</sup>
5. On May 9, 2018, I called the phone number listed on Seattle 7 Days Limo’s website, (425) 361-9283, and posed as a potential customer under an assumed name. I asked if the company was able to provide transportation service for a group of 22-29 people for a bachelor party on June 16, 2018. Seattle 7 Days Limo stated that it has a party bus and a Hummer that could accommodate a group that size and would be available on June 16, 2018. The company stated that the party bus for 28-30 people would cost \$1,920 for eight hours, and the stretch Hummer for 28-30 people would cost \$1,560 for eight hours.<sup>8</sup>

**TE161298 - Cancellation of Permit or Certificate CH066145 Due To Insufficient Proof of Insurance**

Dear Singh, Jagdip and Singh, Gurdip:

On November 7, 2016, the Washington Utilities and Transportation Commission (Commission) notified you that your transportation certificate would be canceled unless you submitted acceptable proof of insurance by December 22, 2016. Our records show that you failed to submit acceptable proof of insurance by that deadline. As a consequence, **the Commission has CANCELED your certificate. You must immediately CEASE all operations associated with this certificate.**

**You have the right to a hearing.** If you believe the Commission should not have canceled your certificate, you may ask the Commission to schedule a hearing before an administrative law judge. At the hearing the only issue the Commission will address is whether you had proof of insurance on file to avoid cancellation. Your request should be addressed to Steven V. King, Secretary, 1300 S. Evergreen Park Dr. SW, P.O. Box 47250, Olympia, WA 98504-7250. You may also email your request to [records@utc.wa.gov](mailto:records@utc.wa.gov). The Commission must receive your request within 14 days after the date of this letter.

**You may apply to reinstate your certificate.** Download the reinstatement application at [www.utc.wa.gov](http://www.utc.wa.gov). To locate the application, go to Quick Links on the front page, select "Transportation Permit Applications" and the appropriate industry application.

**Description:** Called phone number (425) 361-9283, which is the phone number listed on Seattle 7 Days Limo's website ([www.seattle7dayslimo.com/contact-us](http://www.seattle7dayslimo.com/contact-us)). The man who answered the call greeted with "limo service". I inquired if I was speaking with Seattle 7 Days Limo, and the man answered yes.

I posed as a potential customer, asking if the company was available on June 16, 2018 for a group of 22-29 people for a bachelor party. The man on the phone stated that the company has a party bus and a Hummer that would accommodate a group of that size, and would be available on June 16, 2018.

I explained that I went to both the company's website and the company's Facebook page and noticed that they had a party bus on Facebook without pricing, and the Hummer on the website had pricing, but only provided pricing up to 4 hours. I asked the man how much it would cost for each vehicle for 8 hours, potentially more.

The man stated that the party bus for 28-30 people would be \$240 per hour plus the driver's tips, and that it would cost \$1,920 for 8 hours. The man stated that the stretch Hummer for 28-30 people would be \$1,560 plus the driver's tips for 8 hours.

The man stated that the party bus is fairly new. I made a comment that I was surprised that the party bus is more than the stretch Hummer, and the man stated that the company has to pay for the party bus somehow.

I explained that I need to talk with all of the guys for the bachelor party as to which vehicle they would like to take, and stated that I would likely take the Hummer due to the price difference. I asked the man if there is a deposit required to reserve one of the vehicles for June 16, and he responded that the deposit is \$500 and the remainder of the costs would be due on the day of the event. I asked if he could send me an email to confirm all of the pricing information, and he stated that the company only sends confirmations after the trip has been booked and the deposit has been paid.

I stated that after I had a chance to speak with the party, I'd be giving him a call to reserve a vehicle for June 16. The phone conversation was then mutually terminated.
