**ERRATA TO ORDER 04**

RE: *In the Matter of Puget Sound Energy Clean Energy Implementation Plan Pursuant to WAC 480-100-640,*  
Docket UE-210795

TO ALL PARTIES:

On June 1, 2022, the Washington Utilities and Transportation Commission (Commission) entered Order 04, Prehearing Conference Order and Notice of Hearing (Order 04) in the above-referenced docket.

It came to the Commission's attention that Appendix B to Order 04 contained an error. Appendix B provided an incorrect deadline for "PSE Rebuttal Testimony and Exhibits; Staff, Public Counsel, and Intervenor Cross-Answering Testimony and Exhibits" as December 12, 2023. The correct date is December 12, 2022. Appendix B is amended in part to reflect this corrected date. Footnote 4 in Appendix B remains in effect and is not amended:

It also came to the Commission's attention that Appendix A to Order 04 contained certain errors. The heading for Appendix A incorrectly referred to Dockets UE-220066 & UG-220067 instead of UE-210795, and Appendix A provided incorrect phone numbers for the Public Counsel Unit of the Attorney General's Office (Public Counsel). Furthermore, following the prehearing conference, Commission staff (Staff) requested that the Commission update a phone number
