The only tariff sheets omitted from this submission are the tariff sheets for the pilot programs that were proposed and accepted as part of this proceeding. These pilot programs include Schedule 19 - Residential Service – Time of Use Pilot, Schedule 29 - Non-Residential Time of Use Pilot, the time of use pilot option within Schedule 40 – Agricultural Pumping Service, and the pilot autopay credit within Schedule 300 - Charges as Defined by the Rules and Regulations. The remaining tariff sheets will be submitted at a later date accompanied by final monitoring and reporting plans for the pilot programs, as agreed to in the settlement stipulation and directed by the Commission in Order 09/07/12.

The Commission's Order 09/07/12 authorized a revenue requirement decrease of \$4.15 million, or 1.18 percent, to the Company's base rates, effective January 1, 2021. This rate change incorporates the approximately \$1.48 million reduction to the depreciation rates agreed to in

Docket UE-180778 and the return of excess deferred income tax benefits from the Tax Cuts and Jobs Act of 2017 to customers.²

Enclosed as Attachment A is the estimated effect of the price changes, including billing determinants and monthly billing comparisons. The average residential customer using 1,200 kWh per month will see a decrease of \$0.55 per month.

As directed in the Order, PacifiCorp notifies the Commission that the Company accepts the conditions of approval on the settlement stipulation set forth by Order 09/07/12. While each Party will be filing a letter to separately indicate their approval of the conditions in this Order, PacifiCorp has reached out to the Parties and received confirmation that the conditions are acceptable. As a result, PacifiCorp is making this tariff compliance filing.
