Response to WUTC Staff Data Request No. 124

PacifiCorp is completing preparation of Attachment WUTC 124, a schedule which breaks out the IRS Settlement amount in Adjustment 7.7 by audit issue. The schedule is a reorganization of the data provided in Confidential Attachment WUTC Informal 6f. It is expected to be complete soon. Meanwhile the information in Confidential Attachment WUTC Informal 6f will allow significant categorization of the settlement issues.

The settlement costs are allocated among jurisdictions using the average Income Before Taxes (IBT) factor for Washington. Use of this allocation factor would not change under a control-area based allocation methodology since existing deferred taxes and related assets would remain situs-assigned to the jurisdictions that generated them. As noted in response to WUTC 121, Washington, Oregon, and California constitute PacifiCorp's western control area while Utah, Idaho, and Wyoming constitute the eastern control area.
