**RE: Dockets UE-191024, et al—Compliance Filing—Order 09/07/12
Time of Use Pilot Programs, Automatic Payment Credit and Fee-Free Payment
Pilot Program, and Monitoring and Reporting Plans**

In accordance with RCW 80.28.060, WAC 480-07-880, and WAC Chapter 480-80 et. seq., PacifiCorp d/b/a Pacific Power & Light Company (PacifiCorp or Company) submits the following revised tariff sheets in compliance with the Washington Utilities and Transportation Commission's (Commission) Order 09/07/12 in Dockets UE-191024, UE-191750, UE-190929, UE-190981, UE-180778 (*Consolidated*). PacifiCorp respectfully requests an effective date of May 1, 2021.

The proposed tariff sheets describe the four different pilot programs that were proposed and agreed upon in settlement in the Company's recently approved general rate case. Under Schedule 19, the Company proposes to implement a residential time-of-use pilot program for up to 500 customers on a first-come, first-serve basis. Under Schedule 29, the Company would also offer a non-residential time-of-use pilot program for up to 100 customers. Similarly, the Company is proposing revisions to Schedule 40 to include a time-of-use pilot program for up to 200 irrigators during the summer months of June through September when irrigators are more likely to use energy. Lastly, the Company's proposed automatic payment credit and fee-free payment pilot program is detailed in proposed revisions to Schedule 300 and Rule 10. Under the pilot program, customers would be offered a monthly bill credit of \$1.00 for enrolling in an

automatic payment option that pays their electric bill directly from a bank account. PacifiCorp is also proposing to eliminate credit card fees and pay station fees as part of this pilot program.

In compliance with Order 09/07/12, parties collaborated in a series of meetings to develop the enclosed monitoring and reporting plans for the four pilot programs described above. The monitoring and reporting plans reflect the in-depth engagement and valuable input from the Public Counsel Unit of the Washington Attorney General's Office and The Energy Project through a collaborative and inclusive process that was led by Commission Staff. The parties sought and received additional feedback from representatives of Front and Centered, and the Yakima Valley Chapter of the Asian Pacific Island Coalition, who represent low-income and vulnerable populations in the PacifiCorp service area. This feedback was valuable in ensuring that each monitoring and reporting plan included the consideration of equity issues and an evaluation of how these pilots will impact low income and customers from vulnerable populations. PacifiCorp appreciates the hard work that all stakeholders have put into ensuring that the pilot programs are not only successful, but also provide valuable information and data.

On paragraph 121, Order 09/07/12 also required that the Company "include a report, along with its decoupling report, addressing the [time-of-use] pilot programs and quantifying the decoupling mechanism's impact on rates in the data received from the pilot programs." For the pendency of each time-of-use pilot, the Company therefore plans to include this information in its annual decoupling filings where it requests changes to its Schedule 93 – Decoupling Revenue Adjustment prices.
