On September 14, 2017, Hydro One Limited (Hydro One), acting through Olympus Equity LLC an indirect, wholly-owned subsidiary, and Avista Corporation (Avista) filed their Joint Application for an Order Authorizing Proposed Transaction with the Washington Utilities and Transportation Commission (Commission) whereby Olympus Equity LLC would acquire all of the outstanding common stock of Avista, and Avista would become a direct, wholly-owned subsidiary of Olympus Equity LLC and an indirect, wholly-owned subsidiary of Hydro One.

On October 25, 2017, the Commission entered Order 02, Prehearing Conference Order; Notice of Hearing (Order 02). In Order 02, the Commission stated that the time and place for public comment hearings would be determined at a later date. The Commission now establishes the time and place for public comment hearings to provide members of the public with an opportunity to present oral comments to the Commission. The Commission will accept written comments until the record in this proceeding is closed.
