Dear Mr. Johnson:

On December 14, 2020, the Washington Utilities and Transportation Commission (Commission) entered Final Order 09/07/12, Rejecting Tariff Sheets; Approving and Adopting Settlement Stipulation; Approving and Adopting Settlement Stipulation Subject to Conditions; and Authorizing and Requiring Compliance Filing (Order 09) in Dockets UE-191024, UE-190750, UE-190929, UE-190981, and UE-180778 (*Consolidated*).

On April 19, 2021, PacifiCorp filed with the Commission its revised tariff sheets, including Tariff Sheet for Schedule 93, Decoupling Revenue Adjustment, to comply with Order 09 in Dockets UE-191024, UE-190750, UE-190929, UE-190981, and UE-180778 (*Consolidated*). The proposed rates were approved and became effective on May 1, 2021.

On August 17, 2021, PacifiCorp filed a compliance filing, providing a replacement Tariff Sheet No. 93.1. The Company recently discovered that the clean version of Tariff Sheet No. 93.1 in Attachment C in the April 19, 2021 compliance filing did not reflect the correct rates even though the track change version of the same tariff sheet in Attachment B did. PacifiCorp has been charging customers the correct rates based on Attachment B since May 1, 2021. PacifiCorp proposes to correct the inadvertent administrative error. This revision does not change the existing rates or the May 1, 2021 effective date.

Commission Staff reviewed the compliance filing provided by PacifiCorp dated August 17, 2021, and finds that it is reasonable and necessary to revise Tariff Sheet No. 93.1, Decoupling Revenue Adjustment. Staff believes that the filing complies with the Commission's Order 09, entered December 14, 2020.
