RE: Wash, Utils, & Transp, Comm'n v, PacifiCorp, d/b/a Pacific Power & Light Co., Dockets UE-191024, UE-190750, UE-190929, UE-190981, & UE-180778 (Consolidated)

TO ALL PARTIES:

On December 14, 2020, the Washington Utilities and Transportation Commission (Commission) entered Final Order 09/07/12, Rejecting Tariff Sheets; Approving and Adopting Settlement Stipulation; Approving and Adopting Settlement Stipulation Subject to Conditions; and Authorizing and Requiring Compliance Filing (Order 09) in Dockets UE-191024, UE-190750, UE-190929, UE-190981, and UE-180778 (Consolidated).

Order 09, among other things, approved a settlement of the Parties with provisions to implement certain pricing pilot programs. The Commission also required PacifiCorp, d/b/a Pacific Power & Light Company, (PacifiCorp or Company) to include a report, along with its decoupling report, addressing the TOU pilot programs and quantifying the decoupling mechanism's impact on rates in the data received from the pilot programs.²

On March 26, 2021, PacifiCorp submitted revised tariff sheets to comply with the requirements of Order 09.

On April 19, 2021, PacifiCorp filed updated tariff sheets to include small corrections and clarifications. The filing included a Tariff Sheet for Schedule 93, Decoupling Revenue Adjustment, and included a version showing the proposed edits to Tariff Sheet No. 93.1 in Attachment B to the filing, and a clean version of Tariff Sheet No. 93.1 in Attachment C.

On April 29, 2021, the Commission issued a letter in these consolidated dockets finding that the revised Tariff Sheets filed by PacifiCorp on March 26, 2021, as updated on April 19, 2021, complied with Order 09 and approved the revised tariff sheets, which became effective on May 1, 2021.

On August 17, 2021, PacifiCorp filed with the Commission replacement Tariff Sheet No. 93.1. The replacement tariff sheet corrects an inadvertent administrative error recently discovered in Attachment C to the updated tariff sheets filed with the Commission on April 19, 2021: this clean version of Tariff Sheet No. 93.1 did not reflect the correct rates to be charged to customers. Fortunately, the error has not impacted the rates charged customers: PacifiCorp has been charging customers the rates approved by the Commission as provided in Attachment B of the same filing, which does not contain the error.

On August 18, 2021, Commission staff (Staff) filed with the Commission a letter indicating that it believes PacifiCorp's revision to replacement Tariff Sheet No. 93.1 is reasonable, necessary, and complies with Order 09.

PacifiCorp's actions to discover and correct the administrative error in Tariff Sheet No. 93.1 are consistent with the Commission's best expectations of regulated companies. Such correction is necessary even though the error did not affect rates charged customers. PacifiCorp's filing makes no changes to rates as it is purely administrative and ensures that the tariff sheet accurately reflects the current rates and charges approved by the Commission. The Commission finds that the replacement Tariff Sheet No. 93.1 filed by PacifiCorp on August 17, 2021, complies with Order 09. Accordingly, the Commission approves replacement Tariff Sheet No. 93.1.
