REQUEST NO. 2: RE: Wildfire Plan

Please refer to the Response Testimony of Amy I. White's, Exhibit AIW-1T, at 25, which recommends that \$1.6 million of the pro forma adjustment Avista requested for Wildfire capital spending be approved, as this amount is consistent with Commission Policy regarding assets placed in service after the rate effective date.

- a) Please confirm that Staff did not specifically examine the prudence of the Wildfire capital spending Ms. White recommends be approved in the \$1.6 million pro forma adjustment. If this cannot be confirmed, please provide any analysis Staff completed regarding the prudence of these investments.
- b) Please confirm that Staff recommends the referenced pro-forma capital spending adjustments due solely to the fact that they qualify as pro forma adjustments, and that Staff presumes these particular capital investments to be prudent absent a specific prudence review. If these cannot be confirmed, please explain.

After review of these materials and others that Staff did not keep copies of, Staff examined Avista's proposed Wildfire Mitigation Plan. In the course of this examination, Staff reviewed Avista's actual 2020 capital spending at the account level, which included installation of distribution reclosers; distribution line hardening; transmission construction to facilitate inspection and maintenance; and transmission hardening. Ninety-six percent of these funds were spent on distribution hardening, or, in other words, on the infrastructure closest to homes and businesses. Staff chose not to challenge the prudence of the 2020 pro forma expenses associated with the Wildfire Plan because Staff concluded, using knowledge gained from the subject matter review described above, that the plan and the associated 2020 expenditures are reasonable in light of today's conditions and norms.

b. Not confirmed. Staff has proposed known and measurable spending be allowed as a pro forma adjustment in accordance with Commission policy, especially the "Policy Statement on Property that Becomes Used and Useful After Rate Effective Date" as issued in Docket U-190531. Staff did so after its review of Avista's Wildfire Plan, which is discussed above.
