TO ALL PARTIES:

On March 14, 2001, the Commission provided due and proper notice to all parties that it would convene a Second Prehearing Conference on June 7, 2001, and an evidentiary hearing on June 11, 2001, to continue from day-to-day until the record is complete. The parties anticipated the hearing could require five business days, through June 15, 2001.

On May 30, 2001, the Commission convened a Status Conference, at which time the parties asked the Commission to reschedule the Second Prehearing Conference from June 7, 2001 to June 8, 2001. The parties also asked the Commission to schedule the evidentiary hearing to begin on Tuesday, June 12, 2001. The parties estimate that the hearing will continue for no longer than three days. The Commission grants the parties' request.

NOTICE OF PREHEARING CONFERENCE: The Commission gives notice further that it will convene a prehearing conference on June 8, 2001, beginning at 9:30 a.m., in Room 108, Chandler Plaza, 1300 S. Evergreen Park Drive S.W., Olympia, Washington, unless changed by the Secretary or the presiding officers. The purpose of the prehearing conference is to exchange witness lists, proposed exhibits, to discuss the order of presentation of witnesses, and to conduct such other business as will improve the efficiency of the hearing.

NOTICE OF HEARING: The Commission gives notice that it will convene the evidentiary hearings in this docket on June 12, 2001, beginning at 9:30 a.m., at the 24th Floor Training Room, Bank of California, 900 4th Avenue, Seattle, WA. The parties and witnesses must check in

at the receptionist desk, on the 20th floor of the Bank of California building in order to gain access to the 24th Floor Training Room.

NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT: The Commission has set aside time during the hearing schedule to hear comments from members of the public. **The Commission gives notice that the public comment session in this matter will be held at the same location as the evidentiary hearings. The Commission will hold the public comment sessions on June 12, 2001, between 4:00 p.m. and 5:00 p.m., and on June 13, 2001, between 1:00 p.m. and 2:00 p.m.**

Persons who wish to comment must also check in at the receptionist desk, on the 20th floor of the Bank of California building in order to gain access to the 24th Floor Training Room.
