This letter is to provide notice of an opportunity to file written comments on proposed rules and participate in the formal rule adoption hearing.

On October 5, 2005, the Commission filed a Notice of Proposed Rulemaking (CR-102) in this docket with the Code Reviser. The proposal makes changes to WAC 480-93-005(18), WAC 480-93-017, WAC 480-93-178(5), and WAC 480-93-200(1)(e) and (6)(b) and (c). This action begins the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.
