STIPULATION OF SHUTTLE EXPRESS,
INC., EVERGREEN TRAILS, INC.
D/B/A GRAY LINE OF SEATTLE AND
GATEWAY SHUTTLE SERVICE, INC.

1 Shuttle Express, Inc. ("Shuttle Express"), Evergreen Trails, Inc. d/b/a Gray Line of
Seattle ("Gray Line", collectively with Shuttle Express referred to as the "Protestants"), and
Gateway Shuttle Service, Inc. ("Gateway") stipulate to the following:

2 Gateway agrees to narrow the authority it seeks in this docket (as amended by
Gateway's August 23, 2005 letter to the Commission) by adding the underlined text shown
below and removing the stricken text:

3 PASSENGER SERVICE: Door-to-door, by reservation only:

BETWEEN: Clallam and Jefferson Counties, on the one hand and Seattle
and Tacoma hospitals, Amtrak stations, Greyhound stations, and the
Seattle-Tacoma International Airport on the other hand, with flag stops in
Kitsap County, and with closed door service between Clallam and Jefferson
Counties, and the indicated points in King and Pierce Counties and closed
door service between Kitsap County and Seattle-Tacoma International
~~Internations~~ Airport.

BETWEEN: Clallam and Jefferson Counties and Port Townsend, Port
Ludlow, and Silverdale for passengers whose point of origin or point of
destination is in Clallam or Jefferson County.

Limitations: All passengers transported by Gateway Shuttle Service, Inc. must have either their origin or their destination in Clallam or Jefferson County.

Conditions: Gateway may not provide service to passengers from any point served by Heckman Motors, Inc., d/b/a Olympic Bus Lines, under Certificate No. C-992 without advance reservations made at least one hour in advance of the pick-up times at each such point indicated by Heckman Motors, Inc., d/b/a Olympic Bus Lines, schedule as published from time-to-time in accordance with WAC 480-30-060.

The holder of this certificate may operate a five foot by eight foot trailer when such a trailer is used to carry baggage or express and is towed by a vehicle in which passengers are being transported.

4 The Protestants stipulate that they have no objection to Gateway's application, so long as the Commission adopts Gateway's requested authority with the above amendment. 
