However, Chapter 24.12 of the Clark County Code says nothing about delivering C & D Waste to county transfer stations. Moreover, none of the other allegations in the Complaint assert violation of any other provision of Clark County Code Chapter 24.12.

Consequently, even if the mere assertion of the violation of a county code were sufficient basis to permit a county to intervene, no such basis exists here and Clark County's Petition to Intervene should be dismissed.
