Recommendation:

Take no action, thereby allowing the tariff pages filed on May 16, 2019, by Rabanco Ltd, d/b/a Tri-County Disposal Company as revised on July 22, 2019, to take effect August 1, 2019 by operation of law.

Discussion

On May 16, 2019, Rabanco Ltd, d/b/a Tri-County Disposal Company, (Tri-County Disposal or company) filed a proposal for a general rate increase generating approximately \$118,000 (6.6 percent) in additional annual revenue, to become effective August 1, 2019. The proposed increases are prompted by increased disposal fees, employee wages and benefits, fuel, recovery of newly purchased operating assets and other general operating expenses. The company provides service to approximately 4,800 garbage and recycling customers in Klickitat, Skamania, and Yakima Counties. The company's last general rate filing was for \$229,000 additional annual revenue and became effective July 11, 2014.

Commission staff (staff) has completed its review of the filing and found that the proposed rates were excessive. Staff adjusted the allocation factor used to allocate costs between regulated and non-regulated operations. As filed, the company used customer count to allocate general and administrative costs; staff proposed using the ratio of previously allocated costs to allocate general and administrative costs, which had been utilized in previous filings. These adjustments resulted in \$132,000 (7.0 percent) additional annual revenue. The company and staff agreed to the original proposed additional revenue requirement of \$118,000 and the company filed revised tariff pages on July 22, 2019.

Staff has completed its review of the company's financial books and records and finds the proposed rates, to be fair, just, reasonable, and sufficient.

Customer Comments

On May 31, 2019, the company notified its customers by mail of the proposed rate increase. Staff received three consumer comments, two opposed to the proposed rate increase, one undecided.

General Comments

The amount of the requested increase is the primary concern for all of the customers who commented on this case.

Staff Response

Staff informed customers that state law requires rates to be fair, just, reasonable, and sufficient to allow the company to recover reasonable operating expenses and the opportunity to earn a reasonable return on its investment. Customers were also told that commission staff performs a thorough review of rate filings to ensure all rates and fees are appropriate.

Recommendations:
