## Re: Cascade Natural Gas Draft Integrated Resource Plan, Docket UG-220131

Dear Chair Danner, Commissioner Rendahl, Commissioner Doumit, and Staff:

Columbia Riverkeeper, Washington Physicians for Social Responsibility, Climate Action Families, 350 Seattle, Earth Ministry, Washington Interfaith Power & Light, Wild Idaho Rising Tide, Rogue Climate, 350 Eugene, and 350 PDX submit these comments on the Cascade Natural Gas Draft Integrated Resource Plan (IRP).

We support the Washington Utilities and Transportation Commission's (WUTC) work to decarbonize Washington's energy supplies. The WUTC should not acknowledge any portion of the Cascade Natural Gas (Cascade) Integrated Resource Plan (IRP) that will expand the presence of fracked gas in our communities. Washington is trying to reduce fracked gas use, yet Cascade's IRP overstates potential gas demand while offering inadequate justification for purchasing additional capacity on the Gas Transmission Northwest (GTN) system. The IRP also fails to account fully for new Washington laws and rules that will limit gas use. We are concerned that Cascade's recent activities involve unreasonable and inequitable plans to purchase more fracked gas from Canada, in conflict with the region's goals for reducing climate-changing emissions.

Cascade's decision to purchase 20,000 Dth/d from a new gas pipeline expansion proposed by TC Energy, called GTN Xpress, conflicts with Washington's goals for reducing gas use. The GTN Xpress proposal, currently awaiting a decision from the Federal Energy Regulatory Commission (FERC), would add compression to the existing GTN mainline and expand its throughput by 150,000 Dth/d. Cascade entered into a binding precedent agreement for 20,000 Dth/d of capacity for the GTN Xpress project, and FERC's Final Environmental Impact Statement (FEIS) suggests

that 10,000 Dth/d of the gas could be supplied to Washington.<sup>1</sup> Further, the GTN Xpress project involves the expansion of a compressor station in Starbuck, Washington. TC Energy's application to FERC cites Cascade's previous 2020 IRP as evidence that GTN Xpress is needed, a conclusion unsupported by the previous or current IRP.

In 2022, Washington's Attorney General objected to the GTN Xpress project and disputed Cascade's need for the gas while also highlighting the potential environmental justice pitfalls of the project. The Attorney General's most recent comment to FERC notes the inconsistency between Washington's greenhouse gas reduction goals, as well as those of other states, with the GTN Xpress project, stating:

Washington's Climate Commitment Act prevents covered facilities from collectively increasing annual emissions, and requires them to reduce their emissions over time, consistent with the state's greenhouse gas emission limits. Wash. Rev. Code 70A.65.060. But GTN's Project will more than double the operational emissions from the Starbuck Compressor Station, a covered facility in Washington. ... The Final EIS [for GTN Xpress] does not address either Washington's Climate Commitment Act or Oregon's Climate Protection Program, let alone Cascade's specific obligation under Oregon's Climate Protection Program. It also makes no mention of the Project's consistency with California's laws to curb methane use and transition to renewable energy or with the United States' international commitments and national policy to reduce emissions.<sup>2</sup>

Cascade cannot ramp up its fracked gas supply by 20,000 Dth/d while meeting greenhouse gas reduction goals in Washington and Oregon. Cascade's Two-Year Action Plan states, "Cascade will purchase the anticipated required offsets, allowances, or RNG to meet the carbon reduction goals laid out by the Climate Commitment Act." Cascade has failed to show how it will meet the requirements of Washington's Climate Commitment Act in an efficient, cost-effective way while accounting for expanded gas purchasing from GTN Xpress. The WUTC should not allow Cascade to pass along the cost of the expansion to ratepayers or include GTN Xpress in its plans.

In addition to highlighting conflicts with Washington's clean energy goals, the Motion to Intervene and Protest of Attorneys General from Oregon, Washington and California disputes whether Cascade will require 20,000 Dth/d of additional pipeline capacity at all. Their Motion demonstrates, through Cascade's 2020 IRP filing, that Cascade will definitely not require 20,000 Dth/d for more than 17 years. The Attorneys General write: "Cascade's demand forecast methods are overly simplistic and ignore evidence of market dynamics, customer choice, and state and

local laws favoring electrification," and "Cascade's IRP is not reliable evidence of need for GTN's expansion project."<sup>3</sup> The States submitted an expert opinion in support of their comments.

The 2022 IRP substantiates the concerns expressed by the Washington Attorney General to FERC. Despite overestimating future gas demand, Cascade's analysis indicates that new pipeline capacity is not needed. Cascade states, "In the 2023 IRP, Cascade has not included any additional upstream capacity in its preferred portfolio for the 28-year planning horizon."<sup>4</sup> And, "no incremental upstream transportation was selected as part of this IRP's Top-Ranking Candidate Portfolio."<sup>5</sup> According to Cascade's IRP, purchasing expanded capacity from GTN Xpress may be an unwarranted investment at this time, and its cost should not be included in ratepayer bills.

Additionally, Washington's Attorney General objected to the GTN Xpress project because of its negative implications for community safety and environmental justice, and the WUTC requires utilities to meet customer demand in an equitable manner. The Attorney General commented,

"EPA's scoping comments highlighted that the Starbuck Station is near communities with disproportionately high levels of particulate matter (PM 2.5) and ozone exposure and national air toxics assessment respiratory hazards. EJ Screen 2.0 confirms this. The area within five miles of the Starbuck Station rates at the 90th percentile for PM 2.5, the 91st percentile for Ozone, the 81st percentile for diesel particulate matter, and the 89th percentile for Air Toxics Cancer Risks when compared to regional percentiles. Similarly, Washington's Environmental Health Disparities Map indicates the census tract ranks high for low birth weight, "a globally recognized marker for population health." Scientists have linked low birth weight to air pollution.

Although FERC's analysis downplays environmental justice impacts overall, even the FEIS acknowledges that "impacts on environmental justice communities associated with the Athol and Starbuck Compressor Stations would be disproportionately high and adverse as they would be predominately borne by environmental justice communities."<sup>6</sup> The UTC requires Cascade to meet its customer needs in an environmentally just and equitable manner. Accordingly, the WUTC should not allow Cascade to include GTN Xpress in its gas supply plans.

Cascade cannot demonstrate the need for expanded pipeline capacity and increasing demand for gas without fully addressing the changing landscape for fracked gas use in Washington's buildings and the overall trend towards electrification. For example, in 2022, Washington established new building codes that curtail the role of gas in new buildings. Cascade's IRP does

not adequately incorporate the impact of these changes in its demand projections. For example, the IRP states, "Cascade will look into incorporating end use forecasting into the load forecast model. With the increase in building code changes, Cascade will need to gain a better understanding on usage by end use and how the building code changes will impact future demand."<sup>7</sup>

Finally, we could not help but to notice that the IRP makes reference to pipeline and gas supply projects that are mothballed or canceled, such as the Trail West Pipeline and the Pacific Connector Pipeline. The Pacific Connector Pipeline was canceled in 2021, and it should be removed as a consideration from Cascade's IRP.

Washington is setting a course away from fracked gas, but Cascade is working to lock in additional fracked gas pipeline capacity with negative implications for environmental justice, public safety, greenhouse gas pollution, and costs to ratepayers. Thank you for your work to help Washington chart an equitable path away from reliance on fossil gas. Additionally, please see the attached comment petition from 285 people who support efforts to reduce fracked gas in Washington and who urge the WUTC to keep GTN Xpress out of Cascade's plans.
