RATE INCREASE NOTICE FOR RESIDENTIAL GARBAGE AND RECYCLING

Dear Customer:

December 28, 2022

Murrey's Disposal Co., Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (UTC). The Company previously sent letters to you regarding this increase that had the incorrect rates. This letter has been updated to reflect the correct current rates, proposed rates, new effective date, and UTC open meeting date. The last general rate increase was approved by the UTC January 1, 2019. Since that time, the Company has experienced higher costs for employee wages, benefits, fuel, truck equipment and has purchased additional capital assets.

If approved, the proposed rates below will become effective **February 1, 2023**. The rate per month will increase as follows:

UTC staff will make a recommendation to the Commissioners at an open meeting which is scheduled for 9:30 a.m. on Thursday, **January 26, 2023**. This open meeting will be conducted remotely.
