NOTICE CANCELING PREHEARING CONFERENCE

NOTICE OF VIRTUAL BRIEF ADJUDICATIVE PROCEEDING

TO ALL PARTIES:

On September 23, 2024, Eagle Towncar Service LLC (Eagle Towncar or Applicant) filed with the Washington Utilities and Transportation Commission (Commission) an application for authority to operate as an auto transportation company in Washington (Application).

On September 25, 2024, the Commission issued a notice of pending application allowing affected parties 20 days to object to the application.

On October 15, 2024, Pacific Northwest Transportation Services, Inc. d/b/a Premier Airport Shuttle/Capital Aeroporter (Pacific Northwest Transportation) filed a protest to the application.

On October 31, 2024, the Commission issued a Notice of Virtual Prehearing Conference (Notice) scheduling the prehearing conference (PHC) for November 15, 2024, at 10:00 a.m.

On November 7, 2024, Counsel for Eagle Towncar reached out to the presiding officer requesting that the Commission cancel the PHC and instead set this matter for a brief adjudicative proceeding (BAP). Staff agreed this matter would be appropriate for a BAP.

The Commission finds there is good cause to cancel the PHC and hear the matter at a BAP.
