

NOTICE OF REQUIRED INFORMATIONAL FILING

RE: Consolidated Proceedings : *Air Liquide, et al. v. PSE*, Docket No. UE-001952; and *Petition of Puget Sound Energy, Inc., For an Order Reallocating Lost Revenues Related to any Reduction in the Schedule 48 or G-P Special Contract Rates*, Docket No. UE-001959

TO PUGET SOUND ENERGY:

The Commission received through its presiding Administrative Law Judge in this docket a copy of certain e-mail correspondence dated May 18, 2001, between counsel for Puget Sound Energy (PSE) and counsel for Commission Staff. The e-mail correspondence poses the question whether PSE needs to submit Schedule 448 and Schedule 449 Service Agreements. PSE states that "[s]ome customers may execute such agreements in the next few weeks."

The Commission determines that PSE should file the Service Agreements for informational purposes. If any Service Agreement includes information that meets the requirements of WAC 480-09-015 governing the submission of "confidential" information, PSE may file the Service Agreement consistent with the cited WAC provision. PSE should confirm with each affected customer prior to filing whether the customer wishes to assert confidential status under WAC 480-09-015.

Since Service Agreements may be executed at different times, a single date for filing is inappropriate. Instead, the Commission requires that each Schedule 448 and Schedule 449 Service Agreement be filed within ten (10) days from the date of this Notice, or within ten (10) business days after receipt by PSE of a fully executed Service Agreement submitted to PSE after the date of this Notice.
