Driving Route for Judge Torem
1-8-08

Start:

Mount Vernon Police and Court Campus (1805 Continental Place).

Travel south to East College Way (SR-538).

Turn right and travel west on East College Way to the I-5 Interchange.

Enter I-5 southbound and travel south to Exit 226.

Turn right and travel west on Kincaid Street to intersection with South 2nd Street.

Turn left on South 2nd Street and travel south – note you will pass a city of Mount Vernon Fire Station (901 South 2nd Street).

South 2nd Street becomes Old Highway 99 South at the intersection with the railroad tracks (Blackburn crossing).

Continue south on Old Highway 99 South to the I-5 Interchange, just south of Hickox Road.

Turn left and proceed across the I-5 overpass.

Turn left on Cedardale Road.

Turn right on East Hickox Road to the Cedardale Fire Station (19746 East Hickox Road). Note: the rock quarry is approximately one mile past the fire station on East Hickox Road.

Backtrack to the I-5 overpass and proceed over the freeway.

Turn left and travel south on the Conway Frontage Road (Old Highway 99 South becomes the Conway Frontage Road at the I-5 Interchange) to the intersection with Fir Island Road/SR-534.

Turn right and cross BNSF mainline tracks, travel west on SR-534/Fir Island Road. The Conway Fire Station is on the left side of SR-534 at Greenfield Street.

Take an immediate right onto Dike Road and proceed northerly crossing Kayton Slough and passing Dike District No. 3 Headquarters on the left side of Dike Road.

Turn right on Peter Johnson Road and proceed east. Cross the BNSF railroad tracks and proceed past Skagit Valley Gardens and turn left onto Conway Frontage Road. Go north to the intersection with Stackpole. Turn left and travel west on Stackpole to the railroad crossing. Continue west to Dike Road and turn right.

Travel north to the intersection with Hickox Road.

Turn right and travel east on Hickox to the railroad crossing.

Backtrack to Dike Road and turn right.

Travel north to the intersection with Britt Road.

Turn right and follow Britt to the intersection with Blackburn Road.

Turn right on Blackburn and travel east to the railroad crossing.

Turn Right on Old Highway 99 South. Proceed south on Old Highway 99 South to the intersection with Pederson Lane. Pederson Lane is unmarked, use Valley Moving and Storage as a landmark. Turn right and proceed across the BNSF railroad tracks, then turn around and return to Old Highway 99 South. Turn right onto Old Highway 99 South and proceed to the Hickox Road intersection and turn right.

Go west to Dike Road and turn right. Follow Dike Road to the Mount Vernon Wastewater Treatment plant on Britt Road. Turn left and follow the arterial. At the Cleveland stop sign, turn left and proceed to Kincaid Street.

Turn right onto Kincaid and go east to the I-5 North on-ramp and turn left to go north to the College Way exit and back to Continental Place which is the site of the hearing.
