Pursuant to the Washington Extended Interim Participatory Funding Agreement ("Funding Agreement"), approved by the Washington Utilities and Transportation Commission ("WUTC" or "Commission") in Order 02 in Docket No. U-210595, the Alliance of Western Energy Consumers ("AWEC") hereby submits its proposed budget in the above-captioned proceeding.

On January 18, 2024, Avista Corporation d/b/a Avista Utilities ("Avista" or the "Company") filed its request for a general rate revision for its electric and natural gas service. The Commission docketed these filings as UE-240006 and UG-240007. On January 31, 2024, the Commission issued Order 01 in this proceeding, consolidating Dockets UE-240006 and UG-240007.

Dockets UE-240006/UG-240007 are Eligible Proceedings for Fund Grants under Article 1(c) of the Funding Agreement. Accordingly, a Fund Grant may be made for this proceeding under the Funding Agreement.

On February 14, 2024, as required by Article 6.2 of the Funding Agreement,

AWEC filed its Request for Case Certification and Notice of Intent to request a Fund Grant,

which was also served on Avista and all parties of record in the proceeding. In that filing,

AWEC identified the Avista Customer Representation Sub-Fund as the account from which

AWEC intends to request a Fund Grant.

As of the date of this filing, the Commission has not ruled on AWEC's Request

for Case Certification; however, in Avista's prior general rate case as well as other general rate

cases that have come before the Commission, the Commission has found that AWEC

demonstrated it is a non-profit organization that represents broad customer interests, 1 that "it can

effectively represent the particular customers it seeks to represent,"² and that "the public interest

is served by AWEC's participation" and "no other party adequately represents the interests of

industrial customers." AWEC is filing its request prior to the Commission's determination on

AWEC's Request for Case Certification given the requirement in the Funding Agreement that

Proposed Budgets be filed within 30 days of the Prehearing Conference in a proceeding unless

an alternative date is set by the Commission.⁴

Pursuant to Article 6.3 of the Funding Agreement, AWEC files this Proposed

Budget in this case for an Avista Customer Representation Sub-Fund grant in the amount of

\$85,000. As discussed below, AWEC will also incur the additional expense of procuring

directly an Aurora license to review Avista's net power costs in this proceeding. If additional

Statement of work to be performed by AWEC for which AWEC is seeking a

<u>Fund Grant.</u> AWEC has retained Davison Van Cleve, P.C. to represent it in these Dockets.

AWEC will attend all workshops, settlement conferences, public meetings, oral presentations

and hearings. AWEC will also conduct discovery in this proceeding. In addition, AWEC will

submit expert witness testimony and briefs as called for by the procedural schedule in this case.

Description of the general areas to be investigated by AWEC. AWEC intends

to investigate all economic and policy aspects of Avista's filing. General issues include Avista's

request for approval of a proposed Two-Year Rate Plan, performance-based ratemaking, revenue

requirement items such as cost of capital, capital additions, net power costs, operating expenses

and revenues, as well as rate spread and rate design. AWEC will also review issues raised by

other parties.

Identification of the specific Sub-Fund from which AWEC is seeking a Fund

Grant and an estimate of the amount of available funds in that account, if known. AWEC is

seeking a Fund Grant from the 2024 Avista Customer Representation Sub-Fund, which currently

has a balance of \$200,000 to AWEC's understanding.

A budget showing estimated attorney fees, which may include the cost for

appropriate support staff and operational support. AWEC's proposed budget, setting forth

estimated attorney fees, support staff costs and operational support costs, appears in Exhibit A.

A budget showing estimated consultant fees and expert witness fees, which

may include the cost for appropriate support staff and operational support. AWEC's

Cooperative Efforts. In accordance with Article 6.6 of the Funding Agreement, AWEC coordinated with the other organizations who filed Notices of Intent to Request a Fund Grant from the Customer Representation Sub-Fund – The Energy Project and NW Energy Coalition. As part of those discussions, the parties reached agreement on the amounts each organization would request in participatory funding. As such, AWEC is not aware of any objection to its proposed budget.

Additional Considerations. Article 6.5 of the Funding Agreement sets forth several factors that the Commission may consider when making a determination on budget requests. In aid of the Commission's decision, AWEC provides the following information:

- a. The breadth and complexity of issues in this proceeding are significant. General rate case proceedings implicate all aspects of a utility's revenue requirement, including expenses, revenues, capital additions, cost of capital and rate spread/rate design. Moreover, Avista's 2024 rate case raises several policy issues as described below. Evaluation of this rate case will require substantial effort and expense by AWEC to ensure just and reasonable rates for industrial customers.
- b. Avista's Two-Year Rate Plan raises a number of policy considerations, including issues regarding replacement resources for Colstrip impacting Avista's net power costs, resources to meet Washington's Clean Energy Transformation Act requirements, wildfire mitigation costs and cost recovery mechanism, insurance expense and related cost recovery mechanism, and changes to Avista's Energy Recovery Mechanism.

c. The procedural schedule in this case assumes a fully litigated case, which requires

discovery, pre-filed written testimony, workshops and settlement conferences, as

well as a hearing, briefing and any other events the Commission may deem

appropriate. As such, AWEC's participation will be extensive.

d. For Rate Year 1, the Company proposes an electric rate increase of \$77.1 million,

or 13.0%, and a natural gas rate increase of \$17.3 million, or 13.6%. For Rate

Year 2, Avista proposes an increase of \$53.7 million, or 11.7%, for electric rates

and \$4.6 million, or 3.2%, for natural gas rates. These represent significant rate

increases for Avista's industrial and large non-residential customers. Any change

to Avista's rates could substantially impact the rates Avista charges to its

customers, including AWEC's members, and therefore warrants considerable

scrutiny.

e. The Commission has previously recognized AWEC as an "incumbent"

organization with a history of representing industrial customers' interests before

the Commission,⁵ and determined that "no other party adequately represents the

interests of industrial customers."6

f. As shown in Exhibit A to this Proposed Budget, AWEC anticipates that its costs

will significantly exceed its budget request in this case, assuming a fully litigated

proceeding. To the extent that AWEC's costs are greater than Fund Grant

amounts, AWEC will bear the costs of its participation. AWEC notes that, as

anticipated costs associated with its participation in a fully litigated proceeding.

As noted above, AWEC will also for the first time be required to obtain its

own intervenor license for Aurora access, which is necessary to review Avista's

net power costs in this proceeding. According to Avista, this new requirement is

due to process changes within Energy Exemplar, the license holder for Aurora.

The cost to obtain an intervenor license for the limited purposes of this case is

\$5,000. In informal discussions with Avista, Avista indicated its preference that

AWEC obtain the license at its own expense and use the participatory funding

process to recover the costs associated with the license. On a non-precedential

basis, and after discussions with The Energy Project, NW Energy Coalition, and

Commission Staff, AWEC agreed to this approach given the support of these

parties as well as Avista. AWEC is in the process of obtaining an intervenor

license from Energy Exemplar to ensure timely access to review Avista's net

power costs. However, AWEC does not believe that intervenors should be

responsible for bearing the cost of licenses necessary to review material

components of a utility's rate filings, which is effectively what will occur here if

AWEC's allocation of participatory funding is reduced by the cost of an Aurora

license, as it will divert resources that AWEC would otherwise use to review

Avista's filing and participate in the case. Accordingly, AWEC reserves the right

to request an increase to the amount of the Avista Customer Representation Sub-

Fund to cover the cost of the Aurora license. AWEC anticipates the same issue to

arise in Puget Sound Energy's ("PSE") General Rate Case filing, Docket UE-

240004/UG-240005, which will require AWEC to obtain its own intervenor

Aurora license to evaluate PSE's net power costs. In the interest of judicial

economy, AWEC intends to file a single joint request to increase both the Avista

and PSE Sub-Funds to cover the cost of these licenses at the time it files its

budget in the PSE rate case.

g. AWEC represents the interests of large energy consumers and has significant

experience participating in Commission proceedings involving the Commission

and Avista. In addition, AWEC has participated in numerous previous cases

related to setting rates for Avista. Thus, AWEC possesses significant interest and

expertise with respect to this proceeding. AWEC's participation will benefit all

Avista industrial and large non-residential customers.

h. The level of available funds in the Avista's Customer Representation Sub-Fund

for 2024 is \$200,000. As such, AWEC's request is within the limits of available

funding.

i. Given the limited nature of the Avista Customer Representation Sub-Fund, the

number of other parties eligible to seek a Fund Grant in this case, and the

significance of both the number and substance of issues raised in this proceeding,

AWEC anticipates utilizing available Avista grant funds in this proceeding and

does not anticipate seeking additional Fund Grants from the Annual Fund Amount
