Thank you for taking the time to meet with me yesterday to discuss the Wallula PCA facility haul that Jammie's has been performing. Following up on that discussion, I was hoping you might share some additional information that would help us moving forward. Specifically, we were curious how and when Staff's current position that the haul is not in fact exempt was relayed to Jammie's and whether that was relayed to PCA. PCA has not yet reached out to Basin to commence service, and we hope to avoid any contentious issues when Basin contacts PCA.
