RE: Docket UE-191024—PacifiCorp’s Final Compliance Report on Pilot Programs

PacifiCorp d/b/a Pacific Power & Light Company (PacifiCorp) proposed providing three new time of use (TOU) pilots and a payment pilot as part of its 2019 general rate case in Docket UE-191024. The Washington Utilities and Transportation Commission (Commission) approved these pilots on December 14, 2020, in Orders 09/07/12, but with the condition that PacifiCorp collaborate with parties to develop monitoring and reporting plans for them. After a series of meetings with parties, on March 26, 2021, the Company made a compliance filing that included the agreed-upon plans and tariff sheets to make the pilots effective on May 1, 2021.

The plans also required the Company to file a preliminary check-in report on the initial 18-month period of the pilots no later than six months after the end of the period, which PacifiCorp submitted in May of 2023, and a final report six months after the end of three program years (May 2021 through April 2024). PacifiCorp submits this final report accordingly, which includes an evaluation of the residential time of use pilot, the non-residential time of use pilot, and the automatic payment credit and fee-free card and pay station payments pilot. Since no customers elected to enroll in the irrigation time of use pilot, the Company did not submit an evaluation of that program.
