On August 8, 2018, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to implement Substitute Senate Bill (SSB) 6519. The Commission filed the CR-101 under Docket TP-180402. On that same date, the Commission issued a notice of opportunity to submit written comments on draft rules Commission staff prepared.

On September 19, 2018, the Commission issued a Notice of Workshop to review and discuss any comments. The workshop was held on October 19, 2018.

Commission staff has considered written comments from stakeholders, as well as those provided during the workshop and informal discussions, to amend the draft rules.
