DECLARATION OF  
JASON HOXIT

I, Jason Hoxit, under penalty of perjury under the laws of the state of Washington, declares as follows:

- 1 I am over 18 years of age, a citizen of the United States, a resident of the state of Washington, and competent to be a witness.
- 2 I am employed by the Washington Utilities and Transportation Commission (Commission) as a Compliance Investigator in the Transportation Safety Division. As a Compliance Investigator, my responsibilities include conducting investigations into the operations of regulated and unregulated transportation companies. As part of those duties, I investigate charter and excursion service carriers that may be operating without the required Commission-issued certificate.
- 3 On April 12, 2017, Satwinder Singh, d/b/a Luxury1 Limo, LLC, Black Car Seattle, LLC, Luxury Limos & Tours, et al, (Luxury1 Limo or Company) filed with the Commission an application for charter and excursion authority, which was assigned to Docket TE-170250.<sup>1</sup> In the application, Luxury1 Limo provides a phone number of (206) 578-2151; lists its physical and mailing address as 32010 111<sup>th</sup> Ct SE, Auburn, WA 98092; provides an email address of [luxury.limo.seattle@gmail.com](mailto:luxury.limo.seattle@gmail.com); lists its website as [www.luxurylimoseattle.com](http://www.luxurylimoseattle.com), and provides UBI: 603-160-017. The application also identifies that Luxury1 Limo operates three vehicles: (1) a 2001 Freightliner bus with license plate C77444H with a seating capacity of 26 passengers,<sup>2</sup> (2) a 2005 Ford Excursion with license plate LUXURY1 with a

seating capacity of 14 passengers,<sup>3</sup> and (3) a 2006 Hummer H2 with license plate C95458A with a seating capacity of 14 passengers.<sup>4</sup>

- 4 On May 31, 2017, the Commission granted Luxury1 Limo a certificate to provide charter and excursion service in the state of Washington.<sup>5</sup>
- 5 On June 27, 2019, Luxury1 Limo filed with the Commission a request to cancel its certificate to provide charter and excursion service in the state of Washington.<sup>6</sup> On June 27, the Commission issued a cancellation letter in Docket TE-190541, notifying Luxury1 Limo that its authority to provide charter and excursion service was canceled and that the Company “must cease all operations associated with this certificate.”<sup>7</sup>
- 6 On November 1, 2019, the Commission served the Company Order 01, Order Instituting Special Proceeding; Complaint Seeking to Impose Penalties; Notice of Hearing (Set for December 10, 2019, at 9 a.m.); Subpoena and Subpoena Duces Tecum in Docket TE-190842.<sup>8</sup>
- 7 On December 6, 2019, Luxury1 Limo filed with the Commission an application to reinstate its charter and excursion authority, which was assigned to Docket TE-191008.<sup>9</sup> In the application, Luxury1 Limo provides an unregistered trade name of Luxury Limos & Tours; a phone number of (206) 578-2151; lists its physical and mailing address as 32010 111<sup>th</sup> Ct SE, Auburn, WA 98092; provides an email address of [luxury.limo.seattle@gmail.com](mailto:luxury.limo.seattle@gmail.com); lists its website as [www.luxurylimoseattle.com](http://www.luxurylimoseattle.com); provides UBI: 603-160-017, and identifies a 30-passenger 2001 Freightliner bus with license plate C77444H as the only motor vehicle the Company operates.
- 8 On December 10, 2019, the Commission entered Order 02, Stipulated Initial Order Classifying Respondent as Charter Party or Excursion Service Carrier; Ordering Respondent to Cease and Desist; Imposing and Suspending Penalties on Condition of Future Compliance (Order 02) in Docket TE-190842.<sup>10</sup> Order 02 assessed a penalty of \$10,000 against Luxury1 Limo for two violations of Revised Code of Washington (RCW) 81.70.260(1) for operating

as a charter party or excursion service carrier in the state of Washington after the cancellation of its certificate.

- 9 In Order 02, the Commission suspended a \$9,000 portion of the penalty for a period of two years on the conditions that: (1) Luxury1 Limo refrains permanently from further operations as a charter party or excursion service carrier in the state of Washington without first obtaining the required certificate from the Commission, and (2) Luxury1 Limo pays the remaining \$1,000 penalty in accordance with the payment schedule in Appendix A.
- 10 In the transcript from the December 10, 2019, special proceeding, Luxury1 Limo acknowledges that: (1) the Company reviewed and understood Order 02 in its entirety; (2) Luxury1 Limo was penalized \$10,000 for advertising and offering to conduct operations after the cancellation of its certificate; (3) the Company agrees to shut down operations until it obtains authority from the Commission; (4) if the Commission found Luxury1 Limo advertising or offering to provide charter party or excursion carrier services without the required authority during the two year suspension period, the Company would have to pay the \$9,000 suspended penalty; (5) if the Commission found the Company operating in violation of the cease and desist order, Commission staff (Staff) may file a complaint with Superior Court and seek additional penalties, and (6) Luxury1 Limo understood legally what it can and cannot do without a certificate from the Commission.<sup>11</sup>
- 11 On February 18, 2020, Luxury1 Limo paid the \$1,000 portion of the penalty that was not suspended in Docket TE-190842.
- 12 On April 20, 2020, I emailed [luxury.limo.seattle@gmail.com](mailto:luxury.limo.seattle@gmail.com) to notify Luxury1 Limo that it was not in compliance with the payment arrangement established in Docket TE-180596 for penalties that were the result of violations identified during a 2018 safety audit.<sup>12</sup>
- 13 On May 1, 2020, Luxury1 Limo responded from the email address of [info@luxurylimoseattle.com](mailto:info@luxurylimoseattle.com) and states the Company is not operating.<sup>13</sup> The Company's email includes the name of Luxury Limos & Tours and the phone number of (206) 578-2151 in the signature line.
- 14 On June 23, 2020, the Commission entered Order 03/01, Order Dismissing Application without Prejudice and Canceling Payment Arrangement (Order 03/01) in Dockets TE-180596 and TE-191008.<sup>14</sup> Order 03/01 canceled Luxury1 Limo's payment arrangement in Docket TE-180596 and dismissed the Company's application to reinstate charter and excursion authority in Docket TE-191008.
- 15 On September 22, 2020, I received a complaint pertaining to Luxury1 Limo's operations. The complainant alleges that Luxury1 Limo operates a 20-passenger Hummer H2 and a

white party bus without the required Commission-issued certificate. The complainant also states Luxury1 Limo operates a Lincoln Navigator SUV under its active limousine endorsement through Washington Department of Licensing (DOL).

- 16 On October 26, 2020, I searched Commission records, which produced records showing that Luxury1 Limo is not a certificated charter or excursion service carrier in the state of Washington.<sup>15</sup> Commission records reflect the mailing address of 32010 111<sup>th</sup> Ct SE, Auburn, WA 98092, a phone number of (206) 578-2151, an email address of [luxury.limo.seattle@gmail.com](mailto:luxury.limo.seattle@gmail.com), and the website of [www.luxurylimoseattle.com](http://www.luxurylimoseattle.com).
- 17 On October 26, 2020, I searched Washington Secretary of State's Corporations System (SOS) and Washington Department of Revenue's Business Licensing Service (BLS), which produced records showing two businesses registered to Satwinder Singh: Luxury1 Limo, LLC, and Black Car Seattle, LLC.
- 18 BLS and SOS records for Luxury1 Limo, LLC, reflect UBI: 603-160-017, provide a physical and mailing address of 32010 111<sup>th</sup> Ct SE, Auburn, WA 98092, and list Satwinder Singh as the governing person.<sup>16</sup>
- 19 BLS and SOS records for Black Car Seattle, LLC, reflect UBI: 604-282-090, provide a physical and mailing address of 32010 111<sup>th</sup> Ct SE, Auburn, WA 98092, and list Satwinder Singh as the governing person.<sup>17</sup> BLS records show the Company has an active limousine endorsement through DOL for one vehicle and lists the registered trade names of Black Car Seattle/Luxury Limo, Luxury1 Limo, LLC, Navjot K Shoker, and Satwinder Singh.
- 20 On October 26, 2020, I visited Luxury1 Limo's Facebook page, which provides an address of 32010 111<sup>th</sup> Ct SE, Auburn, WA 98092, a phone number of (206) 578-2151, the website [www.luxurylimoseattle.com](http://www.luxurylimoseattle.com), and an email address of [info@luxurylimoseattle.com](mailto:info@luxurylimoseattle.com).<sup>18</sup> Luxury1 Limo's Facebook page states, "Luxury Limo & Tours provides chauffeured ground transportation for executives, business travelers, special events & meeting professionals. With thousands of sedans, limousines, SUVs, hybrids, vans, mini-buses! Calls [sic] us and find out why [we] deliver excellence!"
- 21 On October 26, I observed six separate posts on Luxury1 Limo's Facebook page between September 24, 2019, and September 24, 2020, where the Company either advertises or enters into an agreement to provide charter or excursion service after the cancellation of its certificate, utilizing a white Stretch Hummer H2 with license plate C95458A and a white

party bus.<sup>19</sup> Luxury1 Limo also advertises a black Lincoln Navigator with license plate BPH7122.<sup>20</sup> In relation to charter and excursion service carriers, a motor vehicle “means every self-propelled vehicle with seating capacity for seven or more persons, excluding the driver.”<sup>21</sup>

- 22 On October 26, 2020, I visited the Company’s website, [www.luxurylimoseattle.com](http://www.luxurylimoseattle.com), which provides an address of 32010 111<sup>th</sup> Ct SE, Auburn, WA 98092, a phone number of (206) 578-2151, an email address of [info@luxurylimoseattle.com](mailto:info@luxurylimoseattle.com), links to Luxury1 Limo’s Twitter, Instagram, and Facebook pages, and a link to the Company’s customer reviews through Google.<sup>22</sup> The Company’s website states it provides the following services: “Night Party Limos,” “Wedding Limos,” “Executive Chauffeur,” “Birthday Party-Bus,” Proms Limousines,” and “Executive Airport Transfers.”
- 23 On October 26, I requested a quote from Luxury1 Limo under an assumed name through the “BOOK NOW” link on the Company’s website.<sup>23</sup> In the request, I state that I am “[l]ooking to book a bus for 18 of us to a bachelor party from Federal Way to CenturyLink Field on 12/13.”
- 24 On October 26, Luxury1 Limo responded to my request for a quote from the email address of [info@luxurylimoseattle.com](mailto:info@luxurylimoseattle.com).<sup>24</sup> In the email the Company states, “[w]e do have a party bus available with a 3-4 minimum @ \$195/hr plus gratuity. If you have any other questions feel free to email us back or you can call us at 206-578-2151.”
- 25 On October 26, I replied to Luxury1 Limo’s email and requested pictures of the party bus.<sup>25</sup> Later that same day, Luxury1 Limo responded to my email and provides interior and exterior pictures of a white Freightliner party bus.<sup>26</sup> The picture of the white Freightliner party bus provided by Luxury1 Limo on October 26, 2020, matches the picture of a white Freightliner party bus posted to the Company’s Facebook page on December 22, 2016.<sup>27</sup>

- 26 On October 26, 2020, I followed a link on Luxury1 Limo's website that directed me to the Company's customer reviews on Google, where I observed five customer reviews that specifically refer to using the Company's Stretch Hummer H2 or party bus over the last year.<sup>28</sup>
- 27 On October 26, I searched DOL's DRIVES application for information on the Company's vehicles. Records show the white Stretch Hummer H2 with license plate C95458A and the Freightliner party bus with license plate C77444H are registered to Luxury1 Limo at 32010 111<sup>th</sup> Ct SE, Auburn, WA 98092.<sup>29</sup> The records show the Lincoln Navigator with license plate BPH7122 is registered to Navjot K. Shoker at 32010 111<sup>th</sup> Ct SE, Auburn, WA 98092.<sup>30</sup>
- 28 On October 27, 2020, I replied to Luxury1 Limo's October 26, 2020, email, where I expressed interest in the Company's white Stretch Hummer H2, inquire how many people can ride in the Stretch Hummer H2, and ask for the associated fare.<sup>31</sup>
- 29 On October 28, 2020, Luxury1 Limo responded via email that the Stretch Hummer H2 seats up to 16-18 passengers, quotes a price of \$175 per hour, and provides interior and exterior pictures of the white Stretch Hummer H2.<sup>32</sup> A limousine endorsement through DOL allows a limousine carrier to operate an automobile with a seating capacity behind the driver of no more than 14 passengers.<sup>33</sup>
- 30 In response to the Company's failure to comply with the conditions of Order 02 in Docket TE-190842, specifically, the condition to refrain permanently from further operations as a charter party or excursion service carrier in the state of Washington without first obtaining the required certificate from the Commission, Staff recommends that the Commission impose the suspended penalty of \$9,000 against Luxury1 Limo.

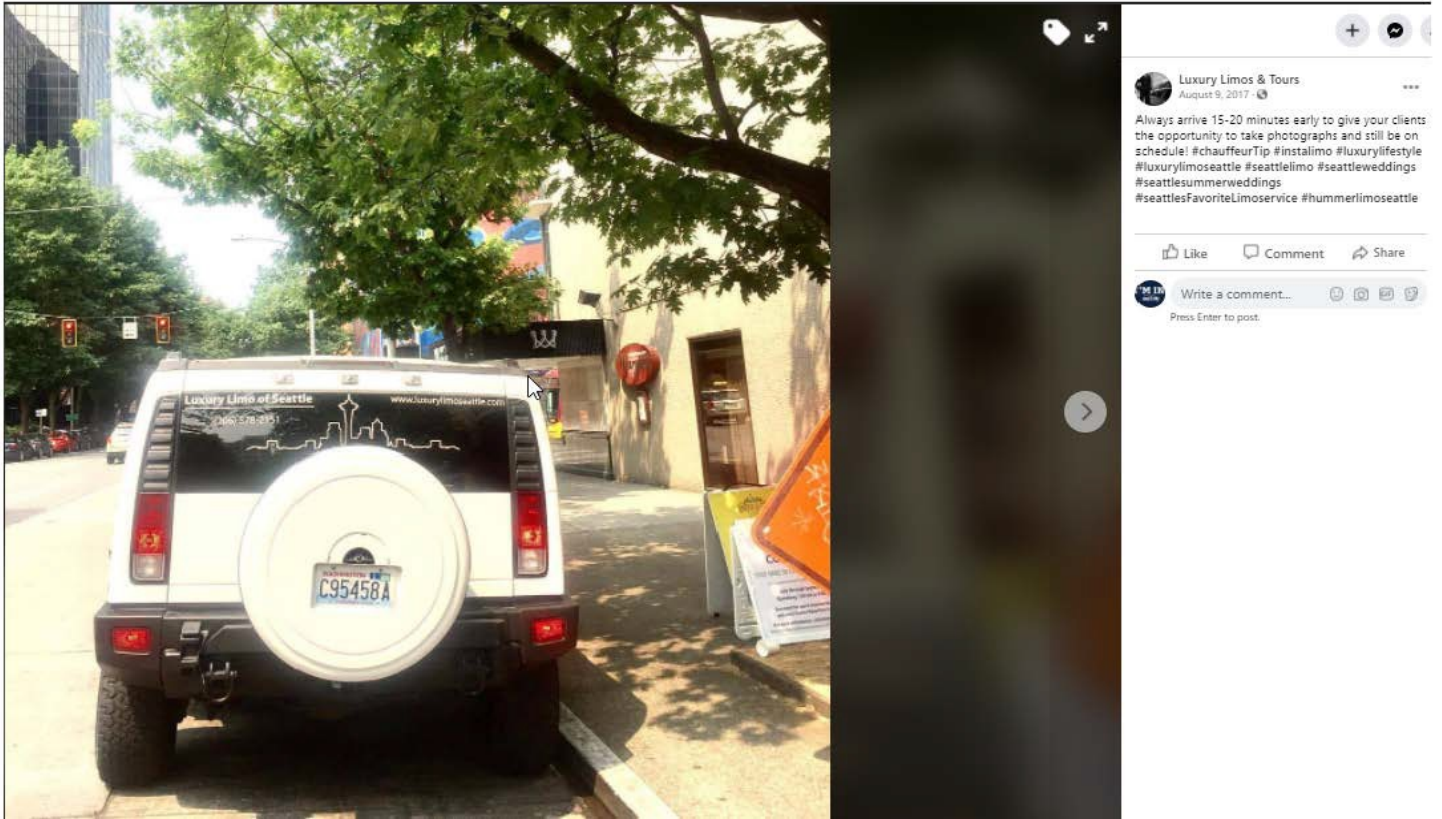

### BACKGROUND

**Synopsis.** *This is an Administrative Law Judge's Initial Order that is not effective unless approved or allowed to become effective as described in the notice at the end of this Order. This Initial Order is based upon a stipulation presented by the parties. If this Initial Order becomes final, Satwinder Singh, d/b/a Luxury1 Limo, LLC, (Luxury1 or Company) will be assessed a financial penalty in the amount of \$10,000 for two (2) violations of RCW 81.70.260(1). An \$9,000 portion of the penalty will be suspended for a period of two years from the date of this order, then waived, subject to the condition that Luxury1 refrains from further operations as a charter party or excursion service carrier without first obtaining the required certificate from the Washington Utilities and Transportation Commission (Commission). In addition, if this Initial Order becomes final, Luxury1 will be classified as a charter party or excursion service carrier and required to permanently cease and desist from operating as a charter party or excursion service carrier without first obtaining a certificate from the Commission.*

- 1 **Nature of Proceeding.** The Commission initiated this special proceeding to determine if Luxury1 has engaged, and continues to engage, in unlawful operations as a charter party or excursion service carrier without the required certificate.
- 2 **Procedural History.** On October 25, 2019, the Commission entered Order 01, Order Instituting Special Proceeding; Complaint Seeking to Impose Penalties; and Notice of Mandatory Appearance at Hearing, pursuant to RCW 81.04.510, initiating this docket on its own motion. The Complaint alleges that Luxury1 violated RCW 81.70.260 by:



- (1) offering on at least one occasion to provide charter party or excursion service in the state of Washington, and
- (2) advertising charter party or excursion services within the state of Washington on at least one occasion

without the required certificate for such operations. On the same date, the Commission issued a *Subpoena and Subpoena Duces Tecum For Production of Documents* (Subpoenas) to the Company commanding Satwinder Singh, owner of Luxury1, to appear before the Commission at a special proceeding scheduled to convene at 9 a.m. on December 10, 2019, in the Commission's Richard Hemstad Hearing Room at 621 Woodland Square Loop SE, Lacey, Washington, and to bring the documents specified in the *Subpoenas*.

3 **Hearing.** On December 10, 2019, the hearing convened as scheduled in Lacey, Washington, before Administrative Law Judge Rayne Pearson.

4 **Appearances.** Michael Dotson, Compliance Investigator, Lacey, Washington, represents the Commission's regulatory staff (Commission Staff).<sup>1</sup> Satwinder Singh, Auburn, Washington, represents the Company, *pro se*.

#### DISCUSSION

5 **Applicable Law.** RCW 81.70.020(1) defines "charter party carrier" as:

every person engaged in the transportation over any public highways in this state of a group of persons, who, pursuant to a common purpose and under a single contract, acquire the use of a motor vehicle to travel together as a group to a specified destination or for a particular itinerary, either agreed upon in advance or modified by the chartered group after leaving the place of origin.

---

<sup>1</sup> In adjudications the Commission's regulatory staff participates like any other party, while an administrative law judge or the Commissioners make the decision. To assure fairness, the Commissioners and the presiding administrative law judge do not discuss the merits of the proceeding with regulatory staff or any other party without giving notice and opportunity for all parties to participate. See RCW 34.05.455.

- 6 RCW 81.70.020(5) defines “excursion service carrier” as:
- every person engaged in the transportation of persons for compensation over any public highway in this state from points of origin within the incorporated limits of any city or town or area, to any other location within the state of Washington and returning to that origin.
- 7 RCW 81.70.260(1) defines “conduct any operations” as:
- advertising or soliciting, offering, or entering into an agreement to provide such service.
- 8 RCW 81.70.260(1) prohibits charter party or excursion service carriers from conducting any operations after the cancellation or revocation of a certificate from the Commission. Upon proof of unauthorized operations, RCW 81.04.510 authorizes the Commission to order the unpermitted company to cease and desist its activities. Additionally, RCW 81.04.110 authorizes the Commission to file a complaint on its own motion setting forth any act or omission by a company that violates any law, order, or rule of the Commission.
- 9 RCW 81.70.260(2) subjects persons who conduct operations as a charter party or excursion service carrier of passengers in violation of RCW 81.70.260(1) a penalty of up to \$5,000 for each violation.
- 10 **Stipulation Presented by Parties.** At hearing, Satwinder Singh agreed that Luxury1 has conducted operations in the state of Washington without the required certificate. The Company offered to provide charter party or excursion service carrier service on at least one occasion in the state of Washington, and also advertised to operate as a charter party or excursion service carrier service in the state of Washington on at least one occasion.
- 11 Luxury1 has agreed to permanently shut down and cease operations as a charter party or excursion service carrier, as defined by RCW 81.70.020, without first obtaining a certificate from the Commission.
- 12 Under RCW 81.70.260(2), Commission Staff is authorized to seek a penalty of up to \$10,000 against the Company. Based upon the above-noted stipulation, Staff now seeks to have \$9,000 of the penalty suspended for two years, then waived, subject to the condition that the Company honors its pledge of future compliance by permanently staying out of the industry without first obtaining a certificate from the Commission.

- 13 The parties agree that the Company's expressed willingness to cease its unlawful operations is a positive factor, mitigating in favor of a lowered penalty amount to be paid now. The parties also agree that the Company's compliance history is a negative factor, making a suspended penalty an appropriate tool to ensure Luxury1 does not re-enter the charter party or excursion service carrier business without first obtaining the required certificate.

#### FINDINGS AND CONCLUSIONS

- 14 (1) The Commission is an agency of the state of Washington vested by statute with authority to regulate persons conducting operations as a charter party or excursion service carrier for compensation over public roads in Washington.
- 15 (2) The Commission has jurisdiction over the subject matter of this proceeding and over Luxury1.
- 16 (3) On at least one occasion, Luxury1 offered to conduct operations after the cancellation or revocation of a certificate from the Commission, in violation of RCW 81.70.260(1).
- 17 (4) On at least one occasion, Luxury1 advertised to conduct operations after the cancellation or revocation of a certificate from the Commission in violation of RCW 81.70.260(1).

#### ORDER


##### THE COMMISSION ORDERS:

- 18 (1) Satwinder Singh, d/b/a Luxury1 Limo, LLC, is classified as a charter party or excursion service carrier within the state of Washington.
- 19 (2) Satwinder Singh, d/b/a Luxury1 Limo, LLC, is ordered to immediately cease and desist operations as a charter party or excursion service carrier within the state of Washington without first obtaining a certificate from the Commission.
- 20 (3) Satwinder Singh, d/b/a Luxury1 Limo, LLC, is assessed a penalty of \$10,000. \$9,000 of the penalty is suspended for a period of two years from the date of this Order, and waived thereafter, provided Satwinder Singh, d/b/a Luxury1 Limo, LLC, refrains permanently from further operations as a charter party or excursion service carrier in the state of Washington without first obtaining the required


certificate from the Commission. The remainder of the penalty, \$1,000, is due and payable subject to the payment schedule in Appendix A.


- 21 (4) The Commission retains jurisdiction over the subject matter and the parties to this proceeding to effectuate the terms of this Order.

WAC 480-07-825(2)(c) states that any party may file a response to a Petition within 10 days after service of the Petition.

WAC 480-07-830 provides that before entry of a Final Order any party may file a Petition to Reopen a contested proceeding to permit receipt of evidence essential to a decision, but unavailable and not reasonably discoverable at the time of hearing, or for other good and sufficient cause. 10          So we will be in recess, and I will be in  
11 my office, so please let me know when I need to come  
12 back. And thank you all for coming down today.

13                   (A break was taken from  
14                   9:24 to 10:19 a.m.)

15          JUDGE PEARSON: Okay. Let's be back on  
16 the record, and it is approximately 10:20 a.m.

17          I understand that Staff was able to reach  
18 agreed cease and desist orders with each company, so I  
19 will call you back up one at a time in the order that  
20 we went before.

21          So Mr. Singh, if you could come forward.  
22 Go ahead and take a seat.

23          So did you have a chance to read the whole

### BACKGROUND

- 1 On July 25, 2018, the Washington Utilities and Transportation Commission (Commission) assessed a \$1,400 penalty (Penalty Assessment) against Luxury1 Limo, LLC, (Luxury1 Limo or Company) for 16 violations of Washington Administrative Code (WAC) 480-30-221 and Title 49 Code of Federal Regulations (C.F.R.).
- 2 On August 29, 2018, the Commission received the Company's response to the Penalty Assessment, admitting the violations and requesting mitigation of the penalty based on the written information provided.
- 3 On September 21, 2018, the Commission entered Order 01, which denied the Company's request for mitigation of the \$1,400 penalty. The Commission, however, exercised its discretion to suspend a \$700 portion of the penalty for a period of two years, and then waive it, subject to the following conditions:

- Luxury1 Limo must not incur any repeat violations of acute or critical regulations;
- Luxury1 Limo must pay the \$700 portion of the penalty that is not suspended or file jointly with Staff a proposed payment arrangement within 10 days of the effective date of the Order;
- Luxury1 Limo must submit a “15-day letter” to Staff within 10 days of the effective date of the Order containing its detailed plan for correcting and avoiding future violations.

- 4 On November 2, 2018, Commission staff (Staff) filed with the Commission a letter explaining that Luxury1 Limo failed to comply with the terms of Order 01 and recommending the Commission impose the suspended portion of the penalty. The Company neither made any payment toward the \$700 penalty nor submitted a 15-day letter as required.
- 5 On November 21, 2018, the Commission imposed the entire \$1,400 penalty. That same day, the Company submitted a \$700 payment to the Commission. To date, the remaining the \$700 portion of the penalty remains unpaid.
- 6 On June 27, 2019, Staff completed a follow-up safety investigation with the Company. During this investigation, Staff discovered repeat acute and critical violations. The same day, the Company submitted a voluntary cancellation of its charter and excursion carrier authority with the Commission.
- 7 On December 9, 2019, the Company filed an application for reinstatement of its charter and excursion carrier service certificate, which was assigned to Docket TE-191008.
- 8 On December 10, 2019, the Commission entered Order 02 in Docket TE-190842 classifying the Company as a charter party or excursion service carrier; ordering the Company to cease and desist such services without first obtaining a certificate from the Commission; and assessing a penalty of \$10,000, a \$9,000 portion of which was suspended for two years subject to certain conditions. The Company paid the \$1,000 unsuspended portion of the penalty in full by February 18, 2020.
- 9 On January 27, 2020, the Company filed with the Commission a request for “the dismissal of the original fine of \$700 [in Docket TE-180596] in order to complete the current permit process.”

- 10 On February 25, 2020, the Commission entered Order 02, Denying Mitigation, Ordering Payment Arrangement (Order 02) in Docket TE-180596. Order 02 required the Company to pay the remaining \$700 of the fine in four monthly installments beginning on March 26, 2020. Order 02 stated that if the Company failed to make any of the payments by the due date the entire balance would become immediately due and payable. Order 02 further stated that if the Company failed to pay the entire \$700 outstanding portion of the penalty by June 26, 2020, the final payment date, the Commission would cancel any charter or excursion carrier authority granted in Docket TE-180596.
- 11 On April 30, 2020, Staff filed a letter in Dockets TE-191008 and TE-180596 informing the Commission that the Company had failed to make any of the payments required by Order 02 and requesting that the Commission dismiss the Company's application in Docket TE-191008 and cancel the payment arrangement in Docket TE-180596.

#### DISCUSSION AND DECISION

- 12 Due to Luxury 1 Limo's failure to make any of the payments required by Order 02, the Commission finds good cause to cancel the payment arrangement. The entire penalty is now due and payable.
- 13 In Order 02, the Commission stated that it would cancel the Company's charter and excursion carrier certificate if the Company failed to abide by the terms of the payment arrangement. Dismissing the application filed in Docket TE-191008 has the same effect as cancelling an existing certificate. Accordingly, the Commission finds that the Company's failure to comply with Order 02 constitutes good cause to dismiss the application without prejudice, and thus grants Staff's request. Should the Company come into compliance with Order 02 by paying the \$700 penalty in full, it may file a new application with the Commission for charter and excursion carrier authority.

#### ORDER

##### THE COMMISSION ORDERS THAT:

- 14 (1) Luxury1 Limo, LLC's application for charter and excursion carrier certificate in Docket TE-191008 is DISMISSED, without prejudice.
- 15 (2) The \$700 remaining balance of the \$1,400 penalty is due and payable immediately.
