RE: In the Matter of the Petition of CenturyLink Companies – Qwest Corporation, CenturyTel of Washington, CenturyTel of Inter Island, CenturyTel of Cowiche, and United Telephone Company of the Northwest to be Regulated Under an Alternative form of Regulation Pursuant to RCW 80.36.135, Docket UT-130477

TO ALL PARTIES:

The Washington Utilities and Transportation Commission (Commission) entered its Order 04, Final Order Approving Settlement Agreements and Establishing Alternative Form of Regulation (Order 04), in Docket UT-130477 on January 9, 2014. Order 04 approved the three settlement agreements and established an alternative form of regulation (AFOR), for Qwest Corporation, CenturyTel of Washington, CenturyTel of Inter Island, CenturyTel of Cowiche, and United Telephone Company of the Northwest (collectively referred to as CenturyLink) for the next seven years. Order 04 also authorized the Commission's Executive Secretary to approve the authorized filing by letter if they comply with the terms of the order.

On February 28, 2014, CenturyLink made six tariff filings in compliance with Order 04 as follows:

On March 17, 2014, CenturyLink filed a revised tariff sheet to Advice No. WA CT 14-03 to correct a typographical error to include the Ames Lake local calling area.

On March 18, 2014, CenturyLink filed Advice No. WA 14-01A in its entirety to correct typographical errors to reflect the appropriate tariff number.

On March 21, 2014, CenturyLink filed revised tariff sheets to Advice No. WA 14-02A to correct typographical errors to reflect the appropriate content, and subsequently on the same day filed revised tariff sheets to correct typographical errors for column heading corrections.
