Regarding: U-180525 Notice of Opportunity to File Written Comments on Proposed Rules and Notice of Adoption Hearing

To David W. Danner, Ann Rendahl, Jay Balasbas, Mark L. Johnson:

This correspondence is also giving Lawful Notice and Demand to the State of Washington Utilities and Transportation Commission and any and all Government, Municipalities, Cities, and Townships Public Officials: This is notice of law as applicable to your corporate and personal financial liability in the event of any violations upon the rights, privileges health and immunities of "We the People" of this state, which the Washington State Jural Assembly represents.

The response by UTC staff to our call for evidence of safety and efficacy is completely inadequate and does not address any of the issues we have clearly and painstakingly pointed out in past communications.

In one recent communication to Jerry Day, Dan Danner, specifically stated that "he hasn't seen any evidence of harm."

Evidence from the scientific studies from around the world show that **every single living being on earth are affected by these frequencies including people of all ages as well as our pets, livestock, birds, bugs, plants, trees, etc.**

On February 7, 2019, Senator Blumenthal blasted the Federal Communications Commission (FCC) and the Food and Drug Administration (FDA)—government agencies jointly-responsible for ensuring that cellphone technologies are safe to use—**for failing to conduct any research into the safety of 5G technology, and instead, engaging in bureaucratic finger-pointing and deferring to industry.**

The U.S. Government has known of these risks since at least 1971, when the Naval Medical Research and Development Command published a bibliography containing 3,700 references reporting 100 biological and clinical effects attributed to microwave and radio-frequency radiation.

Recent findings, such as the \$30 million 2018 U.S. National Toxicology Program (NTP) Study, have corroborated the findings of all well-designed heart and brain cancer studies of people with 10 or more years' exposure to cellular radiation from cell towers and cell phones. They all agree: **RF radiation causes cancer.**

The Mission of the Washington Utilities and Transportation Commission clearly states :

"Our Mission is to protect the people of Washington by ensuring that investor-owned utility and transportation services are **safe**, available, reliable and fairly priced."

Yet the UTC Commissioners, Executive Director/Secretary and Staff have provided **zero** evidence of the **safety** of any of the functioning 4G or 5G equipment and networks. This is unlawful and irresponsible behavior and action, and makes you directly complicit in crimes against humanity, a Capital Offense.

This is our final notice to **cease and desist** the Advanced Metering Infrastructure Rollout using wireless technologies until the safety and efficacy can be determined.

If you continue to ignore the Cease and Desist, action will be taken against all entities, both public and private
