1 other expenses and revenues and levels set during the last
2 generate case.

3 The PCORC portion of this, as filed by the company,
4 requests increased revenue of \$13.1 million, or about
5 3.73 percent. The Limited-Issues Rate Filing would reduce
6 revenue by \$616,000 and pass back about 2.1 million. And
7 there has been a multiparty settlement reached in both of
8 these cases. And if that settlement is approved by the
9 commission, it would increase revenue to the company by
10 11.7 million, and the Limited-Issue Rate Filing would
11 increase the refund 2.8 million.

12 So, tonight, this is an opportunity for you to provide
13 comments to the commissioners pertaining to the rate case.
14 The commissioners act as judges in these formal proceedings,
15 and so we cannot answer any questions from you. We will not
16 take questions from you, but we will take comment from you.

17 And, in fact, if you do have questions, you can email
18 comments@utc.wa.gov or call (888) 333-9882 and ask to speak
19 with Andrew Roberts, and he will direct your question in the
20 right -- to the right place.

21 I'm going to turn it over now to Andrew. Andrew Roberts
22 is with Public Involvement Office at the UTC, and he's a
23 public involvement representative, and he will discuss some
24 of the logistics for our hearing tonight. Andrew?

25 MR. ROBERTS: Okay. Thank you, Chair Danner.

4 CHAIR DANNER: Today is Thursday, November 18, 2021. And
5 this is a public hearing of the Utilities and Transportation
6 Commission. And we're here this evening to deal with two
7 consolidated cases, and those are PacifiCorp's Power Cost
8 Only Rate Case, and that's Docket UE-210402 and its
9 Limited-Issue Rate Filing, which is Docket UE-210532.

10 My name is Dave Danner. I'm chair of the commission, and
11 I'm joined by my colleagues, Commissioner Ann Rendahl and
12 Commissioner Jay Balasbas. And we are going to get ready to
13 take public comment in this case.

14 Let me make a few comments, just to begin, to give a
15 little background on the case. As I mentioned, there are
16 two proceedings before us tonight. There's the Power Cost
17 Only Rate Case, and this is a proceeding that updates costs
18 associated with electric generation and the acquisition of
19 energy from the market. It's a single-issue rate case that
20 adjusts utility rates by updating only the power costs while
21 the utility's other expenses and revenues remain at levels
22 set during the company's last general rate case.

23 The second part of this evening is the Limited-Issue Rate
24 Filing, and this is a narrowly focused rate case that
25 adjusts specific aspects of the utility rates while leaving

1 Again, this is Andrew Roberts with commission staff. A

21 With that, I will turn it back to Chair Danner.

22 CHAIR DANNER: All right. Thank you very much.

23 So let me -- I'm going to go first to the sign-in sheet.
24 Sandy Lloyd signed in to comment tonight. Sandy Lloyd, are
25 you on the line tonight.

 2 CHAIR DANNER: All right. I will come back to Sandy
 3 Lloyd. Ernesto Aguilar, I see that you are on the
 4 participant list. Do you have comments that you wish to
 5 make tonight?
 6 ERNESTO AGUILAR: No, sir.
 7 CHAIR DANNER: All right. Well, let me turn back to Sandy
 8 Lloyd.
 9 (No oral response)
 10 CHAIR DANNER: Well, that is -- that is all I see, so let
 11 me put out a notice. Is there anyone on the call who
 12 has -- who would like -- anybody on the call tonight who
 13 would like to make comments before the commission?
 14 (No oral response)
 15 CHAIR DANNER: All right. I am not hearing any responses,
 16 but Ann Paisner, I see you are on video. Do you wish to
 17 comment tonight?
 18 MS. PAISNER: Yes. Thank you, Chair Danner.
 19 I just wanted to introduce myself, and my name's Ann
 20 Paisner. I'm an assistant attorney general in the Public
 21 Counsel Unit of the Attorney General's Office in the state
 22 of Washington. I just wanted to direct the public to our
 23 website, and our email is utility@atg.wa.gov. If anyone
 24 wants to submit a written comment to us, we're going to be
 25 submitting an exhibit that includes any written comments

1 January 1st, and so I don't know. It might be useful to
 2 have some discussion between the parties and the judge in
 3 that case about the date for comments.
 4 CHAIR DANNER: Yeah. Ann Paisner, that is what I would
 5 propose is that we'll have Judge Howard convene the parties
 6 and they can work that out. But I think that because we
 7 have an effective date for part of this, that we can't
 8 take -- we can't take comment -- and there's no point in
 9 taking comment after we've reached a decision in one of
 10 them. So I would venture that we should set a date that's
 11 sooner, but I will leave that to Judge Howard and to all of
 12 you.
 13 MS. PAISNER: Thank you, Chair Danner. I will reach out
 14 to the parties as well and communicate about that with Judge
 15 Howard as well. Thank you.
 16 CHAIR DANNER: All right. Thank you so much. I
 17 appreciate it.
 18 Let me ask again, is there anyone on the call who wishes
 19 to comment on the proceedings before us tonight?
 20 JESSE TORRES: I have a comment.
 21 CHAIR DANNER: Yes, sir. Go ahead.
 22 JESSE TORRES: My name is Jesse Torres from Yakima,
 23 Washington.
 24 CHAIR DANNER: Okay. Sir, before you go any further --
 25 JESSE TORRES: And I just wanted to make sure that we're

1 that our office has received regarding these proceedings.
 2 And I believe it should be available -- or you should be
 3 able to submit those comments through the date of the second
 4 hearing, which is actually an issue I wanted to bring up and
 5 ask a question about, since we're combining these two
 6 hearings.
 7 I would assume that the record would remain open through
 8 the second hearing in January, which is January 14th, but I
 9 wasn't entirely certain about that. But wanted to provide
 10 our email address and also our snail mail address, if anyone
 11 wants to submit a written comment, and that's Attorney
 12 General's Office, Public Counsel Unit, 800 Fifth Avenue,
 13 Suite 2000, Seattle, Washington, 98104. Thank you.
 14 CHAIR DANNER: All right. Thank you very much. And, in
 15 fact, I will turn to Andrew, before we close, and make sure
 16 that people know where they can submit written comments
 17 through the end of this.
 18 Let me turn to my colleagues, though. We have a hearing
 19 on the Limited-Issue Rate Filing on December 9th, and a
 20 hearing on the Power Cost Only Rate Case on January 14th.
 21 Is it your preference that we leave the record open for
 22 comment through the second hearing?
 23 COMM. RENDAHL: Chair Danner, this is Commissioner
 24 Rendahl, and I believe the request in the limited-issue rate
 25 case settlement is to have rates go into effect by

1 going to be talking about the potential -- or the
 2 increase -- proposed increase on electric rates coming up
 3 the next year, and I just want to make -- rates.
 4 CHAIR DANNER: All right. Great. Let me swear you in, if
 5 you don't mind, sir.
 6 And, first of all, again, let me ask your name.
 7 JESSE TORRES: My name is Jesse Torres. I'm from Yakima,
 8 Washington.
 9 CHAIR DANNER: Okay. And you're a PacifiCorp customer?
 10 JESSE TORRES: Yes, I am.
 11 CHAIR DANNER: All right. So would you raise your right
 12 hand, please. Do you swear --
 13 JESSE TORRES: Okay.
 14 CHAIR DANNER: Do you swear to tell the truth, the whole
 15 truth, and nothing but the truth?
 16 JESSE TORRES: So help you God.
 17 CHAIR DANNER: All right. You may go ahead and make your
 18 comments, then, sir.
 19 JESSE TORRES: Okay. Well, I just wanted to say right off
 20 the top is I am against any increase of energy cost,
 21 especially when American consumers are going through some
 22 hyperinflation. And it's going to affect every part of our
 23 lives, from food to toilet paper. Okay?
 24 All consumers are affected, especially the ones that are
 25 on fixed incomes, like seniors, the middle class, and small

1 businesses. And I think that the timing of this request is
2 very poor timing on the part of Pacific Power, because the
3 people are just trying to hold on with what they got, and
4 this is just the beginning of a lot of things in regards to
5 inflation. And I just hate to see these people suffer any
6 more than they're suffering now because of increased energy
7 rates. My comment.

8 CHAIR DANNER: All right. Thank you very much. I
9 appreciate your calling in tonight and appreciate your
10 comments.

11 Is there anyone else on the phone tonight who wishes to
12 comment on the proceedings before us?

13 (No oral response)

14 CHAIR DANNER: All right. I am not hearing anyone else
15 who wishes to comment, so thank you, Mr. Torres. I
16 appreciate your being here.

17 JESSE TORRES: Yes.

18 CHAIR DANNER: At this point, Andrew Roberts, maybe you
19 want to give some information about where we can -- where
20 folks can submit written comments to be part of this record.

21 MR. ROBERTS: Sure.

22 CHAIR DANNER: Understanding that we have not yet set a
23 deadline, but certainly for the next -- for the foreseeable
24 future we will be accepting comments.

25 MR. ROBERTS: Sure. So we can accept comment online at
