Judges Doyle and Kopta:

Last Friday, the parties convened the scheduled settlement conference in the above-referenced docket. In the hopes of finding a path to partial or comprehensive settlement, CenturyLink proposes a brief (3-week) hiatus to allow the parties to continue their good faith discussions. To that end, CenturyLink proposes the following adjustments to the schedule. Please note that all procedural dates through the evidentiary hearing (including pending discovery due dates) have been extended 3 weeks, and the briefing/decision dates have been extended 4 weeks to accommodate deadlines in other proceedings. Staff and Public Counsel have expressed their agreement to these modifications.
