## **MEMORANDUM**

- NATURE OF PROCEEDING: Docket UT-063061 involves Qwest Corporation's (Qwest) request for arbitration of an interconnection agreement with Eschelon Telecom, Inc., (Eschelon) pursuant to 47 U.S.C. §252(b) of the Telecommunications Act of 1996.
- PROCEDURAL BACKGROUND: On January 4, 2007, the Administrative Law Judge held an informal conference with the parties to discuss rescheduling the arbitration hearing in this matter. On the same date, the parties filed a joint letter confirming their representations during the informal conference that they were amenable to rescheduling the hearing in light of the upcoming retirement of Judge C. Robert Wallis and the Washington Utilities and Transportation Commission's (Commission) resulting resource constraints. In Order 08, Prehearing Conference Order, the Commission vacated the remainder of the procedural schedule and scheduled a prehearing conference in this docket at Olympia, Washington, on January 12, 2007, before Administrative Law Judge Patricia Clark.

- 3 **PREHEARING CONFERENCE:** The prehearing conference convened, as scheduled, on January 12, 2007. At the prehearing conference, the parties agreed to a revised procedural schedule.
