Amendment Number: 3

Description of amendment: This Amendment deletes, changes and adds terms and conditions for certain UNEs as set forth in Attachment 1 and Exhibit A to this Amendment.

The amendment amends the interconnection agreement first accepted by the Commission on December 13, 2000 in WUTC Docket No. UT-003130. That agreement was originally approved by the Commission on August 28, 2000 in WUTC Docket No. UT-003006 between Qwest Corporation and Sprint Communications Co., LC.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B's signature on the amendment, Company A believes that Company B agrees with these representations.
